## Water use drops in Seven Lakes

"A little rain and a lot of cooperation" has helped Seven Lakes reduce its water consumption to targetted level, Moore County Public Works Director Dennis Brobst told *The Times* on Wednesday morning.

Water use that persistently exceeded the 825,000 gallon production capacity of the Seven Lakes system, which is owned and operated by the county, led Moore County Public Utilities to impose Stage II Mandatory Water Conservation measures on Friday, June 8.

The goal was a 30 percent reduction in water consumption, a target of 577,000 gallons used per day. Actual usage in the Seven Lakes system has hovered around that target level for the past week.

"We really appreciate the cooperation of the people," Brobst told *The Times*. "The people of Seven Lakes have once again responded to our call for conservation."

Brobst, who lives in Seven Lakes West, said he walks in (See "Water," p. 2)

## **Board puts off moratorium vote**

Finding themselves between the proverbial rock and hard place when faced with deciding whether to impose a moratorium on new developments in Small Area Planning Area A on Monday night, the Moore County Board of Commissioners managed to wriggle free, with a little help from Planning Director Andrea Surratt and County Manager Cary McSwain.

Rather than impose a moratorium — or decide to turn the developers loose — the commissioners unanimously voted to delay their decision for sixty days. They also instructed the planning staff to hire a consultant to assist in rewriting key

portions of the zoning and subdivision ordinance. This 60-day option was developed by McSwain and Surratt as they prepared for Monday night's meeting and presented to the commissioners during a Monday afternoon work session.

The effect of the decision is to continue a de facto moratorium on new subdivisions in Area A, which has been in place since the commissioners issued a call to public hearing on June 4. Only Area A — a hundred square-mile area centered on West End and Seven Lakes — is affected, and only newly-proposed major subdivisions are

## No parks grant for Foxfire

The North Carolina Parks and Recreation Trust Fund [PARTF] grant sought this year to complete the Foxfire Village Green was not awarded despite many hours of hard work and the services of a professional grant writer, announced Mayor George Erickson during the Village Council regular meeting on Tuesday, June 12.

"We did not do as well as we thought we would," said Erickson.

The village was also denied a PARTF grant last year and Erickson expressed frustration. "The comments made on our grant application were sort of nonsensical," said Erickson.

The review committee comments identified three main deficiencies in the village's application; a suitable survey, demographic data, and limited parks and recreation programming. "Last year they said our survey was too old, so we took a new survey – now," said Erickson, "they say the survey isn't good because it was done after we requested the grant. It's a Catch-22 situation."

Additional PARTF grants will be awarded in July. The village (See "Foxfire," p. 31)



said. Now almost no one is. "I haven't watered my lawn since Sunday," he added.

#### More water on the way

Public Utilities is working to add more capacity to the Seven Lakes system in both the short and long terms. Most of the community's water comes from an interconnection with the countyrun Pinehurst system — a water main that runs along NC Highway 211.

That line has recently been upgraded and a new booster station is planned for installation next spring. That will boost the system capacity by nearly 50 percent.

In the meantime, the department has ordered new impellers for the pumps in the existing booster station. These are expected to increase the flow of water

to Seven Lakes by 140,000 gallons per day — a seventeen percent increase. The new impellers are scheduled for installation in June 30.

"But just because we have this extra water doesn't mean we need to spray it on our lawns," Brobst cautioned.

"But it will be a big help."

## Two injured in accident on NC Highway 211

Two victims were lifeflighted to the Medical Center at UNC Chapel Hill Tuesday morning as the result of a serious threevehicle accident on NC Highway 211 in West End.

One of those transported was Seven Lakes West resident Tyler Horney, of Lee-Moore Insurance in the Seven Lakes Business Village.

As of Wednesday morning, the UNC Medical Center reported Horney in "Good" condition, the best of the four categories of patient status. "Good condition is defined by the hospital as "vital signs are stable and within normal limits; patient is conscious and comfortable; indicators are excellent."

NC Highway Patrol First Sergeant T.D. Simmons has not released any information on the cause of the accident or the identities of the victims.

"I have a theory of what happened, but I want to give these individuals a chance to tell me what they saw, what they were doing, and how that might have affected what happened," Simmons told *The Times*. He said he hoped to speak with the victims as soon as their physical condition would allow an interview.

Times' Editor Greg Hankins happened upon the scene very shortly after the accident took place, before rescue vehicles arrived, and reported the incident to 9-1-1 operators, as did others in the area.

The accident took place just east of the intersection of NC Highway 211 and Knox Lane, just west of the West End Post Office. A late-model, dark-colored Nissan pickup truck was sitting in the center of the roadway pointing east, with massive damage to the left front side of the vehicle.

A toolbox and various articles of yard equipment were scattered across the roadway behind the truck. A middle-aged man, evidently the driver of the truck, was lying on the ground below the open passenger door of the vehicle. He was conscious, but clearly in pain and bleeding from the mouth.

A GMC Yukon was sitting on the right shoulder of the roadway, pointing east, also with massive damage to the front left. Horney was sitting in the driver's seat, pinned in place by the dash. He was conscious, seemed alert, and was able to speak.

Further east a dump truck was parked on the right shoulder of the roadway, also pointing east. First Sergeant Simmons told *The Times* one of the vehicles involved in the incident was a dump truck.

Other motorists attempted to aid both victims and reroute traffic until rescue workers arrived.

West End Fire and Rescue was on the scene just a few minutes after the accident occurred, as was Sheriff's Deputy Mike Kantorowski. Both Moore County EMS and the Seven Lakes Volunteer Fire Department also participated in rescue activities.

The LifeFlight helicopter used a landing zone set up in a hay field at Puckett and Patterson Lanes, West End Fire Chief Wayne Kennedy told *The Times*. Members of Kennedy's squad used Phoenix extraction equipment — commonly called "the jaws of life" — to free Horney from his vehicle.

Moore County EMS Director Scott Brooks confirmed that the two victims were transported via helicopter to the Medical Center at UNC Chapel Hill. No one else was transported from the scene to receive medical attention.

Federal privacy laws — HIPPA — prevent EMS and rescue workers from disclosing information about the identity or condition of accident victims.

Traffic was rerouted down Knox Lane for nearly two hours as rescue operations and cleanup were completed.

## Summit proposals could delay tax hikes

#### The Summit -Why, What, Who

A few years ago George Lane, head of the Pinehurst Civic Group, had an idea. Subsequent discussion with David Warnoff, publisher of the Pilot, lead to their sponsoring what became known as the Summit. Some time later, Patrick Coughlin, CEO of the Moore County Chamber of Commerce, joined them as a sponsor.

The Summit is an ad hoc committee of county and municipal officials established to identify and propose action on - opportunities for improving countywide situations. Summit meetings include discussions of issues of mutual concern and interest. sharing war stories, and learning from each other. On the initial list for discussion were roads, water, wastewater, crime, and substance abuse — just to cite a few from memory.

George Lane asked me to participate as head of the Seven Lakes Civic Group. The fact that larger than eight of the eleven municipalities in Moore County may have been a factor.

#### **Alternative Revenue Sources Committee**

Last year it became abundantly clear that the county and many of the municipalities had immediate critical infrastructure needs - needs that would become even more critical with anticipated growth. These needs were estimated to cost \$305 million (in 2007 dollars) over the next ten years and consisted of

- Public Schools: \$144 million
- Sandhills Community College: \$15 million
- Water, Waste Treatment: \$92 million
- Public Facilities: \$47 million
- Transportation (roads): \$7 mil-With inflation and and addi-

tional needs (both inevitable), the final figure could well exceed \$350 million.

Funding these needs is clearly a monumental problem. Funding these needs with something property tax rates was not considered a viable option. To not fund these needs would significantly lower everyones' property values.

Mike Haney of Southern Pines was named chairman of the Alternative Revenue Sources Committee. Members are officials from nine municipalities, the county, and me.

Our first meeting decided that any proposal had to provide a sustained revenue stream, be a new source of revenue, be implementable, and had to benefit many if not all jurisdictions. Brainstorming (any and all ideas no matter how off-the-wall they seemed, no initial criticism or "we cant do that!" or "they wont let us do that!") and subsequent reality checks lead to two subcommittees — Land Transfer Fee and Shared Services.

#### **Land Transfer Fee**

The press has reported rather thoroughly on this proposal.

Basically, the Land Transfer Fee would establish a fee of

the Seven Lakes community is like a 75 percent increase in one percent of the total price on all sales of land (undeveloped or developed with homes and other structures). A fee of \$1,500 would apply to a \$150,000 sale; \$3500, to a sale of \$350,000. The buyer and seller would agree who pays the the fee (or they could share it). Certain exemptions have been proposed. including transfers within an immediate family, transfers caused by divorce or foreclosure, transfers between subsidiaries and wholly-owned companies, and tranfers to not-for-profit organizations. Other exemptions are being considered such as transfers of prop-

erty less than some to-bedetermined amount.

It's estimated that if the recent trend continues, the land transfer fee would generate \$8-10 million in it's first year. And it's sustainable.

The rationale for a land transfer fee is that it is a one-time user (buver /seller) fee and is an attractive alternative to an 8 to 9 cent increase in the recently approved county tax rate of 44.5 cents per hundred valuation a 20 percent increase!

There appear to be three hurdles in the way of implementa-

## Vandals slash tires, break into pool area

Recent incidents suggest vandalism is on the rise again in Seven Lakes North, and the Seven Lakes Landowners Association [SLLA] appears ready to take harsh measures if the vandals can be identified.

The most severe incident occurred on Friday, June 15, when Security Officer Carolyn Turner found all four tires on her personal vehicle had been slashed while it was parked by the North Gate.

SLLA Security Director Michael Florence told *The Times* that Turner began her shift on midafternoon Friday. She discovered the damage to her vehicle at about midnight, when her shift ended. Her car was parked

near the exit lane at the North Gate. The Association will replace the tires, at a cost of approximately \$400.

Florence said the SLLA is offering a reward for information leading the apprehension

and arrest of the parties responsible.

## SLLA Board delays truck parking decision

## Westsider asks for walking, cycling trails

Westside resident Sherry Niewald spoke during the public comment segment of the June 12 Work Session of the Seven lakes West Landowners Association [SLWLA] Board of Directors, asking the Board to consider building paths for walking and biking in the community.

She said she and her husband, Tim, a builder, had constructed a five-foot sample path on Sheroff Drive, using compacted granite as a surface. That surface is good for both bicycles and walkers, she said, and can be easily dug up if utilities or driveways need to be installed.

The sample path on Sheroff is immediately adjacent to the road, Niewald said, but, ideally, a grass buffer would be placed between the road and the path.

The community needs to have a safe place for people to walk she said, noting that more and more walkers and cyclists are using the roadway on Longleaf Drive. A walking path is a "necessity not a luxury" Niewald said.

"I really feel this is a priority in this community. My children and I are frustrated that we can't ride our bikes anywhere. We have turned this area into a driving friendly area only."

She suggested beginning the process of creating more walk-

ways by adding a path from Smathers Drive to West Side Park and noted that she would be making a presentation on the issue to both the long-range planning committee and the Lake Auman Sports Club.

Gerhard Hergenhahn, who has long been an advocate of walking/bicycling paths in the community, spoke in favor of Niewald's proposal.

"A development of our size being built now would be bragging about trails," Hergenhahn said. "It's a self-understood thing."

He said his research on the issue indicated the original developer had created a wooded buffer zone of more than 200 feet around large sections of Longleaf that could accommo-

date walkways. But that buffer zone was never declared a common area of the Landowners Association. Unfortunately, one of the succeeding developers then sold it to other developers who sub-

divided it into more building lots.

"It is a great step forward that we now get a community movement telling the board what the community needs — the opportunity for community to walk around," Hergenhahn said.

SLWLA President Jim Haggard told Niewald that the Board would respond to her request.

East Gate Status. Security Director Blaine Rowland said a check is expected from the insurance company to help pay for the new barcode-activated gates. "Within the month, we should be up and running," Rowland said. He said he was in favor of having a committee affix the barcodes to residents' vehicles, rather than having residents do it themselves. After some discussion of whether the number of barcodes per home should be limited, Rowland was asked to work with his committee to develop a policy.

West Park Rental. President Haggard reported that he had been working on responding to objections concerning a new deposit policy for West Side Park and Community Center rentals. Some clubs do not maintain a treasury that will allow them to make multiple deposits for multiple meeting dates. In the past deposits were rolled over from one meeting to the next.

After considerable discussion, the Board reached a consensus that the deposit requirement could be waived for clubs on a Board-approved at the discretion of the Community Manager.

Finance. Treasurer Kathy Kirst said her finance committee has discovered that both BB&T and First Bank offer the ability to spread deposits among a number of banks to maintain FDIC coverage on all association deposits. The Association is currently using Merrill Lynch to accomplish this, but Kirst will explore using the local banks instead, in hopes this will help the Association obtain a preferential rate when it comes time to renew the mortgage on the West Side Park loan, which has a balloon that comes due in February

Architectural Review. Director Bill Mamel said the ARC committee has developed a process for assigning inspectors to each new construction project, who will visit the site as soon as a lot clearing permit is issued and check on it periodically thereafter. Drainage and erosion continue to be a problem on new home site he said — a


"We hope to find him a good home with a young child or donate him to a therapeutic riding center," said Old.

## School Board looks at impact of growth

Predicting growth in Moore County Schools [MCS] for the next ten years was a topic of discussion at the Board of Education regular monthly business meeting, held on June 11. Mike Miller, the program manager for Operations Research and Education Lab [OR/Ed] at NC State provided an update to the IPSAC study completed in December 2004.

"Integrated planning for schools and community includes community interviews with municipalities and with county stakeholders," said Miller.

County growth is occurring not only because of the construction of new subdivisions, according to the report, but also because younger families with children are purchasing homes previously built for and owned by retirees. The schools are also growing because of their good reputation.

Miller continued saying that growth constraints in Moore County come from the lack of municipal water and or sewer lines and the lack of "easy transportation service," especially in northern Moore.

The land use 2006 updates include 200 new lots in Aberdeen;

100 lots in Pinehurst; 200 lots in Southern Pines; and 312 in other parts of Moore County. The report updates do not include the proposed new subdivisions in Small Planning Area A.

"There is a conceptual number of 2,700 lots in Area A but those are not counted because they have not been approved through county planning process," said Miller. "But they are poised to be a major factor in growth for Moore."

Miller's report said that Moore County has seen a consistent, stable growth of 193 new students per year for the last six years. Using an allocation of gain formula, in 2004 the report expected 48% of new students to feed into Pinecrest High School. The 2006 updated report shows that 60% of new students will feed into Pinecrest.

The 2006 update also provided capacity analysis for all county schools. West End Elementary and Pinecrest High School are currently over capacity and, the report predicts, West Pine Middle will be over capacity by the 2009-10 school year.

MCS Board member W. Joe Vaughn asked if the 2,700 new homes will affect not just Pinecrest but other county

these proposed homes have the potential to have significant affect, especially on West Pine Middle

Miller also said that the military Base Realignment and Closure [BRAC] affecting Ft. Bragg would influence growth in Moore County but that the historical data does not show that this would be an adverse effect. A University of North Carolina study of BRAC predicts one hundred new students will come in the next year.

#### **MCS Budget**

The Board of Education passed the revised budget proposed by the County Commissioners. Dr. Susan Purser, Superintendent of Schools, said the new \$23.6 million proposed budget was "98 percent of our original request. It's not 100 percent, but I am extremely pleased with the process and the work of both staff."

Purser continued, "There have been hundreds of folks involved, some volunteer and others employees. The commissioners asked us to come have a workshop to discuss our needs and

schools. Miller responded that I was very comfortable that the commissioners would do what they could to support us."

> Moore County Schools will receive Impact Aid, this year, from the federal government and Purser said that right now she does not know what the North Carolina General Assembly is going to do financially which makes it premature to discuss what programs or projects will need to be eliminated due to lack of budget funding.

"The General Assembly seems to be moving a little more rapidly," said Purser, "hopeful we will have the main picture – the state

Purser said that there were several time critical items that she would like the Board to approve including permission to hire new assistant principals, to extend current contracts, and to hire new athletic directors and coach-

"These are essential in getting schools prepared to begin," said Purser. "We will hold on other items and not go forward with the spending but these critical requests are well within the range of money that the County Commissioners have approved





George [A.K.A. Sticky], Kate, and Constance all are joined together by the same mysterious ad in the paper: "Are you a gifted child looking for special opportunities?"

As the children pass their tests and are joined together they set off a fabulous journey to conquer evil, which progressively sews these children's lives together, and they form a support group to last a lifetime.

This novel teaches valuable lessons of teamwork and the value of friendship. Throughout the whole book the four children, each one alone in the world, learn to depend on each other. Not just to work but also for emotional support.

Throughout the novel the kids also slowly develop from a dysfunctional, rag-tag group kids to a caring, if somewhat unconventional, family. The novel shows how the four children truly do need to rely upon each other to succeed.

Whether it is Constance's determination to be difficult. Sticky's memorization capabilities, Reynie's leadership abilities and die hard attitude, or Kate's resourcefulness, each of their and quirks. defining characteristics comes into play in some vital form.

ing the funds and coordinating the establishment of a citywide transportation service for the pickup and delivery of seniors to their medical, dental, and hospital therapy programs.

Rev. Stark has also served as the Director of United Ministries of Irondequoit. Her assignment was to determine the needs of seniors and effect appropriate methods to meet these needs.

## Idol finalist David Radford keeps on singing

David Radford is still singing and not just the jazz and pop standards that won him a slot as a finalist on American Idol last year.

Radford, the grandson of Judy and Loren Swearingen of Seven Lakes North, stopped by Bookshop by the Lakes when he was in town on a family visit. As an Idol contestant, the then 17year-old Radford captured the hearts of the young teen set across the country with his good looks, charm, and convincing renditions of the sorts of songs that made Dean Martin, Frank Sinatra, and Ray Charles

Though the phone-in voting eventually eliminated him from the competition, Radford says participating in the Show was a "one in the lifetime deal" that has won him both confidence and contacts in the music indus-

He's putting those contacts to work as he prepares to go back into the studio to record a second CD. His first CD, released last year, featured his interpretation of standards. The new recording will feature Radford's original compositions.

"I've been composing, and I have about eight songs ready for the studio," Radford told The Times, noting that he has three producers — two in LA and one in New York — listening to his

The new songs are "a lot more modern," Radford said. "I love the standards, but I love today's music as well." He has rewritten the standard "Summertime" with more of a "jazz pop fusion" feel.

"You see a whole different side of things when it's your own material," Radford said. "It's your baby and you get to see it come to life. It's your own art - you expressing your musical individuality and creativity. It's really exciting to me."

Radford told The Times that he does about half his composing on the guitar and half at the

A rising sophomore at the University of Illinois, he plans to major in Vocal Performance and Music Education — and that involves some music of a very different style.

"You're singing operas, performing in recitals and for juries

- singing stuff completely out of your comfort zone," Radford said. "Classical music is your foundation, what you go back to.

Once you learn everything, know what you can and can't do, you can bend the rules in ways that work for you."

But jazz is Radford's first love. "What draws me towards the jazz-pop performing . . . you can still make the piece your own, where the classical is more formal. I like my way of singing the song. But you need that foundation, that home, in classical music."

Radford said he had an offer to perform in the musical Grease this summer, but turned it down because it was going to eat up too much time. Instead he is working as a swim instructor and lifeguard at two lakes near his Home in Crystal Lake, Illinois, earning the capital he'll need to fund his upcoming recording

Teaching swimming is more than a source of income for Radford, who says he loves working with children — and hopes ultimately to include teaching music in his career.

Radford told The Times that he comes from a family where faith is a very important part of life; he has sung in church for years. If he's successful in the world popular music, he said, he would like to cross over into the world of Christian popular music as well.

When The Times asked what advice he might have for young folks considering a career in music, Radford's strong faith came to the fore.

"I don't know what I can say that hasn't been said by so many people. What I try to do to is to

Taking charge of the Project Linus chapter in November 2005, after it had been inactive for 9 months, Weber not only reinvigorated the program but large-


ly through her efforts expanded the blanket program to include Lee and Cumberland Counties, as well as Moore County. In 2006, 1,200 blankets were distributed.





MCS Board Vice Chair Dr. Lorna Clack said "For the assistant principals, this is hiring time. This is when the good candidates are out."

Purser agreed. "We don't need to move on hiring a mechanic or Information Technology [IT] professional staff. Instead we need to look at the most critical staffing issues first." She continued, "We will have to do some reductions."

Charles R. Lambert, a Board member said, "We should fund positions that directly affect the teaching of the children."

Purser said that a final budget will be brought back before the board as they make more adjustments. Her immediate request of funding was due to the time sensitive nature of this hiring. "We typically continue the hiring process through the summer and this is the area that we really need to move on now."

The MCS Board approved the superintendent's request.

#### **Finance Officer**

Michael C. Griffin was named the Chief Finance Officer for MCS. Griffin presently serves as Chief Financial Officer for Pine Needles / Mid Pines Resorts, a position he has held for the past

three years. Prior to that, he served for seventeen years as Deputy County Manager and Finance Officer for Moore County Government.

"We are very fortunate to have someone of Mr. Griffin's skills and experience join our staff," said Purser. "He also has a strong commitment to Moore County contributing to the community not only through his job, but through volunteer work and other areas of service. Mr. Griffin is a welcome and valuable addition to our administrative team."

#### **Science Program**

Beverlee Beale, Executive Director for Curriculum, and Susan Livesay provided a report on the first North Carolina Science Summit. Held in May, the Summit promoted national and state initiatives for enhancing science eduation.

Livesay said the Summit identified the direction of science education at the national level which is to develop scientific literacy. This includes addressing preconceptions, conducting inquiry through discovery, and metacognition.

"We need to know where we want to go," said Livesay, "to develop biology and chemistry courses with pacing guides developed around concept-based instruction with embedded inquiry activities and literacy support."

The MCS summer academy sessions for teachers, to be held in August, will provide inquiry activities and techniques.

The Summit also addressed the small number of science teachers coming out of university today. One reason identified was that most academic hours in college are taken up with general teaching courses and are not science-based.

#### **Electronic Board Meetings**

Jim Tagliareni, Chief Officer for Technology for MCS, presented a report on options available that would allow the MCS Board to modify its current system to a paperless electronic meeting style. Electronic meetings would provide print and materials cost savings and would reduce staff time spent on agenda preparation. Electronic meetings also would allow the board clerk to work more efficiently to produce and publish board meeting packets, agendas, notices, and minutes.

If the electronic board meeting style was adopted, each board member would have a computer stationed at their place at the board table. The members could access the agenda from home using their existing internet or Broadband accounts. During meetings, the members would bring the laptop computer with

Tagliareni said that there are several software applications available for school board use or

that Moore County could develop one in house to best meet the board's needs.


Board member Susan Black suggested that whatever costs would be incurred to adopt this system would be quickly reimbursed through savings on paper materials.

(Continued from page 8) problem drive to some degree by the topography of the sites.

"We are looking to strengthen position with contractors in terms of what we expect before issuing a certificate of completion," Mamel said, noting that, under the Planned Community Act, the Association may be able to link a SLWLA certificate of completion to the certificate of occupancy issued by the county. "This could make a great deal of difference in terms of landscaping and erosion control," Mamel said.

Recreation. Director Jo Nicholas reported that fifty children attended the summer fun kick-off program. Swimming lessons are scheduled for June and in July. Cooking and crafts classes are also in the works, as well as an attempt to bring Sandhills Community College classes to the neighborhood.

Infrastructure. Director Ray MacKay reported that the contract for the next phase of the Lakeway Drive repaving is out for bids, which are due after July 4.

Mailhouses. President Haggard reported that a letter had been received from Congressman Howard Coble's office indicating that the law would not allow him to interfere with the US

Postal Service. Hugh Beckwith noted that the current covenants will have to be changed to allow mailboxes at individual homes.

"We need to put a window on this," Mamel said, noting that, if home delivery is not going to work, the Association is going to need to make a decision about upgrading the current mailhouse, adding additional mailhouses, and so on. "This is a big-ticket area," Mamel said.

Environment. Director Mary Anne Fewkes said it is possible that, during periods of extreme heat, the community could experience additional fish kills. The buildout of properties around the lake have reduced cover for fish, she noted, adding that hot weather can reduce the oxygen level in shallow coves beyond what is needed to support fish.

Emergency notification system. President Haggard proposed creating two new signs for the bulletin board at the front gate, like those used to indicate that their is a Sailing Club Race. One would indicate "Breaking News;" the other, "Emergency." This would alert residents to check the website or mailhouses for more information.

Cooperative Purchasing. Haggard told Board members

application is eligible for this round of awards and Mayor Erickson and the Village Council intend to draft a letter to include with the revised application which will outline how the previously identified deficiencies have been corrected, including details on a recently created parks and recreation program staff position, demographic information, and discussion of the survey. In addition, the Mayor and Council plan to meet with the regional representative for PARTF.

"We will try to get a better handle on exactly what they say. We met with them before and then when we got up to Raleigh, it's you didn't do this and you didn't do that," said Erickson.

Councilman Carl Munro asked if it would make sense to start again from scratch.

"No," Park Committee Chair Jack Olsen responded, "We have completed 80-90% of what needs to be done [in the application process]. We don't need to go through more expense." Olsen continued, "We've been through an awful lot of work."

"We will try again," said Erickson. "We're not going to give up."

#### **Water Moratorium** on Private Wells

Councilman Ed Lauer proposed a resolution placing a 120-day water moratorium on private wells located within village corporate limits. Lauer asserts that increased development and the near draught conditions have placed a burden on existing water resources. An initial study recommends no future private well drilling. However to facilitate more detailed research on how to best provide for future water needs and to provide the time necessary to develop ordinances specifically for private wells, the moratorium was requested and the Council approved unanimously.

"Call them what you will," said Lauer. "These are convenience wells for irrigation, and they draw from the same water that our village wells draw from." He continued, "We're better off than the rest of Moore County. We are not in a serious position - we are about the same as where we have been in previous droughts. These actions are simply to protect the resources for the entire community."

Foxfire Village is currently under voluntary water restrictions that call for a 20% reduction in water use

"The moratorium is on new wells, not current. But I hope that all well owners will obey the same rules for water conservation." Lauer continued, "I only water twice a week. That's all it needs. Those plants do not to be watered all the time and people waste water by dumping it on their lawns in the middle of the day. You lose 60% to evaporation."

Councilman Lauer said that the new computer software billing program is now in use and that water bills will go out in June

and again in July. "The new system will generate bills on a monthly basis," said Lauer.

#### **Public Safety Report**

Councilman Carl Munro reported there have been four to five cases of village residents leaving their garages open and people walking in and taking items. A recent case involved a new home in which a range and new oven were stolen.

"We weren't even notified because the builder wasn't back for several days. The builder estimates there was a ten-day period between the theft and notification," said Munro. "In many cases, there is nothing to go on to even start to track it down."

Munro said residents should

lock both doors and their garages. Fourth of July fireworks displays

nities around Foxfire, said Munro. Displays are scheduled "all around us — Aberdeen, Pinehurst, and Seven Lakes. You shouldn't have any trouble finding a display if you want to go."

Moore County has been selected as a test site for the 2010 Census. The Census Bureau

will need to fill 3,000 census taker jobs, which will pay \$11.50 an hour, during the 2008 test census. These jobs can be worked at your own pace. Councilman Munro said interested persons should contact George Pence in Whispering Pines for more information.

Munro said over twenty com-

munity standards violations were reported last month. Nineteen letters were sent out and several violations were handled by telephone. If the violations remain unresolved after the fifteenth of June, Munro said citations will be issued.

"We hope to get by with just a warning. The violations include not cleaning up lots, trailers storage, garbage cans being left out. A wide variety of things," said Munro. "Years ago the violations were primarily lot clean up, but this time it's more diverse. A few lots have trees down but that's not the dominant problem."

Councilman Munro reported that fifteen residents have completed the twenty-one hour Citizen Emergency Rescue Team [CERTS] training program and are now qualified and would be able to assist in a disaster sequence. A practice drill was held which included responding ambulances and mock disaster work. Munro thanked Craig Ramey for coordinating the drill.

"The primary job of these people is to save lives if necessary,

to eliminate dangerous situations, and to be a transition to more qualified people such as police, fire departments, and EMS," said Munro. "I was happy and pleased with the performance."

Several CERTS participants are also taking three hours course instruction in first aid and CPR.

Munro expressed concern regarding anticipated growth in Moore County, "An awful lot of [Small Planning] Area A comes up close or even overlaps village property and there are several thousand homes planned for the next few years."

Munro suggested that village residents concerned about

growth around Foxfire should consider attending the public hearing on the proposed subdivision moratorium, which was held on Monday, June 18, before the County Commissioners. "Every realtor and every home builder will be there signing up to ask for no moratorium. If you feel differently," said Munro, "you might want to go."

#### **Finance Report**

Councilman Wally Peckitt reported the village bank balances "are depleting but not at an alarming or surprising rate." Peckitt reported the General Fund balance at \$278,037, the



Water Fund at \$136,897, the Water Capital Reserve Fund at \$106,140, and the Supplemental Police Fund at \$14,730.

Providing a summary report of the past fiscal year, Peckitt said that while there has been an increase in expenditures there has also been an increase in revenues; approximately \$3,000 was transferred from the Police Fund to the General Fund and several budget amendments were made . . . We had unexpected changes in the Police Fund due to a new officer, a new chief, and the retirement of our chief."

Peckitt also reported that if a police officer retires after a certain period of service, he is entitled to an annual retirement to be paid by the municipality until the officer reaches 62 years of age.

"Chief Rhyne is entitled to receive an annual amount of \$13,000," said Peckitt. This amount will be paid by the town by monthly installments.

Peckitt's summary report also included that water lines were assessed, the annexation of twenty-nine acres of Pineland Preserve, that the village was engaged in a hydro-structure study of Grande Pines and a water study of future village needs, that the Woodland Circle extension estimated to date costs were \$1.5 million, of which the town has paid \$15,000 to be reimbursed through assessments, a contract was made for extended maintenance of the water tower, and that Foxfire had received all reimbursements of the original Village Green PARTF grant.

#### **Streets Report**

Councilman Gene Petrie reported that in the past, the subdivision ordinance has not been followed. He said that before subdividing, the developer must go to planning and zoning for approval first, and then go to the council for approval.

"Robert Edwards wants to subdivide and he's in a bind," said Petrie. "We need to go through this process before he can subdivide and sell."

Petrie also reported on the status of the property across the street from Town Hall. The owner was asked if he would sell a portion of the land back to village, "and he said no," said Petrie. "He also said he would not clean up the mess that was left behind and said if people wanted to complain that they should call him."

A resident asked if village community standards rules applied to this property. Munro responded that while growth of underbrush and tree stumps does not apply, "We can do something about fallen or dead trees. The laws are specific about what you can or can't do. We can ask him to do some things and cite him."

Mayor Erickson asked if Petrie was aware of the owner's future plans for this land. Petrie responded that the owner said it would be developed into commercial property, but Petrie said there hasn't been any progress yet.

A resident asked if there were ordinances limiting sign dimensions. Petrie said that commercial signs may be larger than residential signs and that the in the past, the owner was forced to move his sign further away from the road to comply with ordinances.

Petrie also reported that while current ordinances state that side entry garages are preferred, "We have one contractor who has built four houses in Foxfire and has plans for six more but all of his homes have front entry garages. Petrie suggests that the current ordinance is not specific enough and should instead read that except for cul-de-sac lots, all houses must have a side-entry garage.

"We'll call our attorney and get her opinion and make sure we're well covered," said Petrie. To change an ordinance, a public hearing must be scheduled before the council can vote. "The ordinance reads now that side entry is "where feasible" which is not definitive," said Petrie. "We won't approve plans in process without this change."

Petrie added that while a community appearance committee can make recommendations to a builder, they can't enforce an

ordinance and that builders usually don't abide their recommendations.

#### **Zoning Report**

Councilman Gene Petrie reported that five sets of plans are under review, and there were four or five others in last week. Mayor Erickson commented that he has recently walked the village and counted forty-seven homes being built.

#### Mayor's Report

Mayor George Erickson reported three recent appointments; Robert Thorne and John Hunter to the Board of Adjustment; and Craig Ramey to Planning and Zoning Board.

Last year, Foxfire issued 400 pool passes and this year the village has already issued 900 passes — some of which are one-day passes. Village residents may purchase a pool pass for \$1; non-residents may purchase a family membership for \$300.

(Continued from front page) involved. Building permits will continue to be issued for homes in existing subdivisions.

The planning staff is working on several changes to the zoning and subdivision ordinances:

- · Revising the Planned Unit Development [PUD] standards to include two types of development — one with more open space for rural areas and a one with greater density for areas within the Urban Services Boundaries. PUDstyle subdivisions may become more common under the new rules currently under development.
- Developing regulations that encourage conservation subdivisions — setting more acreage aside for open space and asking developers to identify the best ground to reserve for open space before laying out streets and lots.
- Resolving some inconsistencies between the Land Use Plan, the Zoning Ordinance, and the Subdivision Ordinance

Before making their decision, Commissioners heard literally hours of testimony from more than two dozen speakers, with both opponents and proponents of the moratorium well represented.

Seven Lakes West builder Todd Meade was the first to speak. Opposing the moratorium, he asked those who shared his position to stand — which brought more than half the gallery to their feet. Setting the tone for opponents of the measure, Meade said a moratorium would hurt workers in the construction trades. He argued that a moratorium, under North Carolina General Statutes, is an emergency measure to protect the public health and not appropriate as a means to buy time to revise ordinances.

"Please do not send the message that Moore County cannot handle the kind of growth that is coming our way," Meade asked Commissioners.

Several officers and members of the Moore County Home **Builders Association echoed** Meade's points, as did Ray Ogden, Director of the Partners in Progress economic development initiative. Planning Board members Aaron McNeill and Ron Jackson also urged the Commissioners to reject the proposed moratorium, as did McRae Smith, the developer who has proposed a "Seven Lakes East" development that would lie just north of Seven Lakes North.

Speaking on the other side of the issue were Planning Board Chair Nancy Roy Fiorillo and Vice Chair Kim Voncannon, along with a number of members of the Area A Small Area Plan Steering Committee. Both Jim Haggard and Mary Anne Fewkes, members of the Seven Lakes West Landowners Association Board, spoke in support of the moratorium. Haggard said a petition circulated in Seven Lakes West during the past few days had attracted 120 signatures in support of the moratorium.

Other Seven Lakes residents who spoke in favor of the moratorium included Don Welch, Nancy Chumley, and Charlie Flinchum.

Surratt will be expected to report back to Commissioners on her progress in hiring a consultant and revising ordinances at their next meeting, on July 16, and again at their second meeting in August. At that meeting, the Commissioners are likely to revisit the request for a moratorium based on the progress the planning staff has made.

Until then, the county will accept no more applications for major subdivisions — those involving five or more lots.

#### **Brenner tract rezoning**

Despite opposition from a number of citizens, the board unanimously approved the rezoning of a 377 acre parcel within the 1,000-acre Brenner Tract located on NC Highway 73 between Beulah Hill Church Road and


Rubicon Road. The area was rezoned to PC Public and Conservation District from a combination of RA Rural Agricultural and RA-40 Residential and Agricultural.

Prior to the vote for approval, Commissioner Tim Lea made a motion to table the rezoning request to allow Commissioners more time to study the project; his motion died for lack of a second.

MHK Ventures, which submitted the rezoning application, plans a 219-home golf course development on the 1,000-acre tract; the 377 acres to be rezoned PC will accommodate the golf course and a driving range. MHK has submitted a sketch drawing for the associated residential development to the county Subdivision Review Board, but has not asked for rezoning or pre-

liminary plat approval for the residential area. Monday night's action dealt only with the acreage reserved for the golf course.

In a work session prior to Monday night's regular meeting, Planning Director Surratt told commissioners that the rezoning requested by MHK would reduce the density allowed on the Brenner property, which, under current zoning, could be developed to hold 600-800 homes.

"I have stated all along that I am comfortable with this proposal, Surratt said. "I feel comfortable with the rezoning." She noted that the use is "in character with the area" and "reduces the density that could be available in that area."

"It is an example of setting aside open space that we haven't had to date," she noted. "We haven't had anyone ask for public and conservation lands zoning in the past."

Last month, the Planning Board, in a four-to-three vote, had approved MHK's request

dards citations out to citizens unaware of the ordinances. "They don't have clue what they are. We need to treat them with a little leniency," she said. As plans for a house go through the application process, she suggested, the future resident should be given ordinances. "We need to provide them the opportunity to know what they can and can't do without a hassle."

A significant obstacle, said Mayor Erickson, is that the book of ordinances was now several inches thick. Someone suggested having a committee draft a summary that would highlight key ordinances.

A resident said that such a summary would allow homeowners to know what is acceptable and what is in violation. "We should not force neighbors to have to confront neighbors."

Charles Coker said "Ordinances are basically rules that we have to live by in this community. I wanted to live in community where they would be enforced." He concluded, "Rules should not be made unless you are going to enforce them."

for rezoning, though the current Planning Board chairman, vice chairman, and the previous chairman all voted against the request. They apparently felt that the entire development — homes and golf course — should be considered as a whole, rather than in parts.

The 377 acres for the golf course lie astride the headwaters of Little River. Many objections to the proposed rezoning focused on the potential for the proposed golf course to both pollute the watershed and to pull too much water out of the river, negatively affecting those downstream. Florence Keith of Whispering Pines told Commissioners that Little River nearly dried up during a drought a few years ago, dropping the level of Thagaard Lake four feet. She asked them to consider the downstream impacts of allowing development upstream.

Joe McDonald, speaking for a new citizen's group called Save our Sandhills, told Commissioners that he had worked on land use plans in a number of counties. When a new major development is proposed, McDonald said, it increases "pressure to cave in and give up on parts of the land use plan. At some point we have to start devising land use plans and sticking with them."

Bob Stolting noted that the Commissioners had previously turned down a proposed rezoning on an adjacent property — the Larsen tract — in 2005, after which the property was purchased by the state as a plant preserve. He called their attention to the presence of wetlands and floodplain areas on the Bren-

ner tract. The proposed golf course is a "large commercial enterprise," not the "public recreation and community facility," appropriate to the PC zoning designation.

Ruth Stolting reminded Commissioners that sections of the Land Use Plan stress preserving rural areas. "Golf courses are not conservation designs," Stolting said. Noting the large number of golf courses already in the county, she added, "There are better solutions than this rezoning to PC for the purpose of a golf course." She suggested that a development centered on a nature preserve, or an equestrian development, would be more marketable and appropriate than another golf course.

Dr. James Gregory, a professor in the Department of Forestry at NC State, cautioned that both the golf course and the subdivision proposed for the Brenner property involve numerous crossings of wetlands and suggested that the developer should consult with the Army Corps of Engineers and the state Division of Water Quality in order to reconfigure the development to minimize wetlands impacts.

Gregory's comments were rebutted to some extent when developer Bob Hanson, the project developer, introduced his environmental consultant, Dr. Jay Carter, who described the work that he had already done with the Corps and state offi-

- On a hot day, restrict exercise and don't take your dog jogging with you. Too much exercise can be dangerous.
- Don't muzzle your dog.

- Avoid places like the beach and especially concrete or asphalt areas where heat is reflected and there is no access to shade.
- Wetting down your dog with cool water or allowing him to swim can help maintain a normal body temperature.
- Move your dog to a cool area of the house. Air conditioning is one of the best ways to keep a dog cool, but is not always dependable. To provide a cooler environment, freeze water in soda bottles, or place ice and a small amount of water in several resealable food storage bags, then wrap them in a towel or tube sock. Place them on the floor for the dog to lay on.

(Continued from page 35) cials on wetlands issues, including crossings.

Hanson spoke at length about the concept underlying the golf course development: "Less is more."

Though 309 acres is being set aside for the 18-hole golf course, he said, only about 80 of those acres will be planted with grass, leaving more than 200 acres in natural Sandhills forest and grasslands. Hanson said the golf course architects he plans to hire "have a perspective of design that limits the playable area."

The goal is a course more like Pinehurst #2 would have looked in the 1960s, before substantial additional acreage was planted in grass. The result will be a largely natural landscape which will actually provide corridors for wildlife, Hanson added.

Other elements of the "less is more" philosophy include a 13,000 square foot clubhouse, as opposed to the more common 40,000 square foot structure, and a goal of 16,000 to 18,000 rounds of golf per year, rather than 40,000 or 50,000.

Reacting to comments from speakers who suggested the county has enough golf courses, Hanson argued that golf is in fact Moore County's primary industry, though no new golf course had been built in the county since 1996. "Without golf this would be a ghost town," he said. "Everyone who lives here benefits from golf."

The Board of Commissioners' approval clears away one hurdle for MHK's golf course, though various permits will have to be obtained from the Corps, state, and county before construction can begin.

Any applications for the residential portion of the development will be delayed by the defacto 60-day moratorium on new major subdivisions in Area A.

#### Other business

During Monday night's meeting, Commissioners also:

 Returned to the Planning Board for further work a proposed ordinance for the creation of Family Subdivisions. The Commissioners asked that the ordinance include tougher language on minimum road standards — par-

- ticularly if lots are eventually sold outside the family. They also suggested adding language that would encourage the preservation, as opposed to the division, of larger tracts of family land.
- Approved an amendment to the Zoning Ordinance to allow public utilities structures pump houses and lift stations
- to be built within the setbacks of the Highway Corridor Overlay Districts.
- Authorized the acceptance of a \$500,000 state grant for the Moore County Airport, to be used in the construction and improvement of taxiways.
- Authorized the issuance of \$7.7 million in bonds to help fund construction of Phase II
- of the East Moore Water Dis-
- Appointed Roger Bone to the Planning Board, Katherine Ewing to the Aging Advisory Council, and Jimmie Ann Lassiter to the Jury Commission.
- Recognized Lanie Wade Garner for 20 years of service as an EMT for Moore County.
- and presented him with the Order of the Longleaf Pine.
- Recognized Carthage Rescue Squad for attaining "Light Rescue Provider" status through the North Carolina Association of Rescue and Emergency Services, Inc.

First, the legislature must approve a bill to establish the fee. County and many municipality officials are now working toward that end. Somehow it only seems right to allow all counties the same right they have granted others.

Second, Realtors® and builders oppose the fee. They have powerful lobbies in Raleigh. 'Nuf said.

Third, it's almost certain that any bill before the legislature will include a provision requiring a county referendum. Considering the alternatives —substantial increases in annual property taxes and in every-day sales taxes —the one-time land transfer fee would be a bargain.

#### **Shared Services**

In Accounting 101, we learned that reducing your expences by \$1 is the same as increasing your income by \$1.

There are four types of shared services — transferring to an independent organization a number of operations and services currently provided by each jurisdiction, transferring to one jurisdiction some operations and services currently provided by each, delegating to one jurisdiction a few operations or services now provided by most jurisdictions independently and entering into a joint agreement where one jurisdiction volunteers to lead in some operation or sevice.

Initiating the first type is far more complex than initiating the fourth — designing the system, impact on employees, significant up-front costs, possible legal issues. Initiating the fourth type is not without its possible problems, but it is really relatively simple.

Initiating the fourth type was chosen. It's an example of "you better walk before you try to run."

After brainstorming ideas and considerable deliberation, the sub-committee agreed to pursue a cooperative purchasing agreement through which any two or more jurisdictions could participate in a Request for Proposal for any purchased item — goods or services — with the aim of a better price than with individual RFPs.

In addition to economies of

scale, specifically as lower prices — a tangible benefit — intangible benefits include learning from each other, better RFPs, opportunities for standardization and good and ever-improving working relationships among those folks in the various jurisdictions responsible for purchasing.

To some extent joint purchasing is not exactly breaking new ground. Today the county provides a number of services for several municipalities — tax collection, fuel purchases, water purchases, GIS services, many to a limited extent, most on an informal basis.

A resolution and the coop-

erative purchasing agreement are now being signed off by the various jurisdictions. Seven Lakes (West, North/South) is included in this initiative. The SLWLA has already signed off; SLLA is expected to sign off at their meeting later this month.

This initiative is clearly walking before trying to run. There are no up-front costs, no operating expenses, no negative impact on employees. With experience, it can be the basis for more complex shared services with greater benefits.

To wrap up, let me say that during many meetings, I observed a very significant change from the first meeting about two years ago and our recent meetings. What started out as a "what's in it for me?"— reserved and guarded discussions and a rather pervasive feeling of distrust—evolved into a "what's in it for us?"— open and frank dialog and mutual trust.

This is a monumental step forward that bodes well for the entire county. As a good friend and member of the Area A Steering Committee recently said "Dear God, don't let us mess this up!"
