Pool policy roils meeting

The debate over new policies and fees for use of the Westside swimming pool erupted in and sometimes nasty squabble during the Tuesday, April 28 general meeting of the Seven Lakes West Landowners Association [SLWLA].

In the course of developing a fee schedule for the coming fiscal year, the Westside Board has both raised the cost of pool use by guests and ended an exemption that allowed the nonresident children and grandchildren of landowners to use the pool without paying guest fees. During their April 14 Work Session, the SLWLA directors were presented with a petition signed by 591 residents, asking

for a return to the FY 2008-2009 number of pool guest passes polices and fee schedule or a public meeting in which the matter could be thoroughly aired.

Tuesday night, Longleaf Drive resident Bob Horne touched off provided to landowners from 14 to 21 and clarified that \$200 annual passes are really good for 120 visits the pool by any number of people, rather than a sea-

son pass for a specific individual.

"That's fine," Horne told the Board Tuesday night, "but that's not the issue. The issues is denying the children and grandchildren the right to

use the pool."

"We gave you over half of the residents of this operation that signed a petition to either go back [to the prior year's policy] or have a public meeting. Just putting it [the Board's decision]

Foxfire begins largest-ever public works project

Construction of the Woodland Circle Extension project in Foxfire Village kicked off Monday, April 20 with a formal Ground-breaking Ceremony.

The 7,500 foot long extension will begin at Eagle Drive, where Woodland Circle currently ends,

and provide a paved roadway, as well as access to the Village water system, for the 14 property owners and 350 acres along its length.

The owners of the properties along the route will eventually be assessed for the cost of the project, which Mayor George Erickson told *The Times* would likely total \$2.3 to \$2.4 million. That includes engineering fees, as well as the expected \$1.6 million paving cost. Erickson said the Village expects the work will be completed by November 15.

Advisory board skeptical of 3-cent tax cut

Moore County's Government Efficiency Advisory Board [GEAB] isn't convinced that the Board of Commissioners can cut the property tax rate, but at least one Commissioner isn't convinced the advisors had all the facts when they reached that conclusion.

GEAB Chairman Dick Westcott walked the Commissioners through an analysis of county revenue and spending projections during their Monday, April 20 regular meeting. The commissioners had asked Westcott and the members of his committee to reflect on two questions: whether county expenses can be cut by five percent in Fiscal Year 2009-2010 and whether the county can cut the property tax rate by three cents. Both moves were proposed by Commissioner Tim Lea in a February Commissioners meeting and have been an ongoing topic of discussion in most of the Board's meeting since

Westscott said the County's FY 2008-2009 budget, as amended on March 23, showed expenses of \$90.3 million, which means a five percent reduction would amount to \$4.5 million. That yields a target expenditure budget of \$85.8 million for FY 2009-2010, if Lea's suggestion is implemented.

The staff had, by April 15, already identified cost reductions that brought it within \$80,000 of the \$4.5 million goal, Westcott reported, giving the GEAB committee confidence that the five percent expense cut could realistically be achieved next year.

Turning to the proposed three cent reduction in the tax rate, however, the committee found that "a tax rate reduction is not feasible at this time," basing that conclusion on County staff calculations that show FY 2009-2010 revenues projected to total \$85.7 million — just shy of the \$85.8 million in expenses achieved through a five percent budget cut.

Westcott noted that, because of the current state of the economy, projections of FY 2009-2010 "have continued to decline and the risk of additional revenue loss remains."

The five percent reduction in expenses could support a four cent tax cut, if next year's revenues were the same as this year's, Westcott told the Commissioners. But, instead, rev-

enue estimates have fallen, wiping out the potential tax benefit of a \$4.5 million cut in expenses

Once Westcott had finished his report, Commissioner Lea said another group of financial consultants, Davenport & Associates, had provided the Board last Thursday with a report that suggested taxes could be cut one cent with no adverse impact on the county's reserves or its ability to fund the construction of a new jail, public safety building, and county administration building.

Westcott said the GEAB had not had an opportunity to meet directly with Davenport, and Lea asked if that would be possible. The meeting of the two groups has since been scheduled for Wednesday, April 29 at 1:00 pm

in the Historic Courthouse in Carthage.

Schools ask for no funding increase

Other organizations that look to the county for a portion of their funding were clearly aware of the Commissioners' inclination to cut costs and, possibly, the tax rate. Moore County Schools [MCS], Sandhills Community College [SCC], and the Sandhills

Center for Mental Health all presented FY 2009-2010 budget requests during the Monday, April 20, meeting seeking no increase in county funding.

MCS Superintendent Dr. Susan Purser told the Commissioners the School Board was asking for just over \$26 million in county funding — the same as this year — despite the fact that the schools know they will have

In the recent Association Amenity Survey the "Yard Debris Site", which is open from 9:00 AM – 4:00 PM Mondays through Saturday and 1:00 PM – 4:00 PM Sundays, was listed as the third most important Association Amenity next to the Gates, Lakes and Beaches. It was also listed as the number one amenity most frequently used by residents and the amenity lest wanted for elimination.

Next to Salaries and Benefits, the Contract for Debris Site operations is the second major cost factor (17.1%) in the Streets and Grounds 2009-2010 year-end expenditures. Not included in that cost figure is the Maintenance Department's additional labor cost for separating authorized

and unauthorized materials.

Authorized materials for disposal at the Debris Site are just that – "Yard Debris" (tree limbs less than 4 inches in diameter, leaves, pinecones, etc.) — unauthorized are unwanted or used lumber, plastic bags and other similar trash. Believe or not we even have residents who dump

their trash by the Sequoia Point trash receptacles for Maintenance to pick up for disposal. The accompanying photographs illustrate part of the problem.

Please be a good Association neighbor and dispose only "yard debris" materials at the Association Yard Debris Site.





Gina Piper's quilt to be raffled at Blue Jean Ball

Joe Piper describes his late wife as a "social creature," someone who could take a ride on a crowded elevator and get off with a couple of new friends.

Gina Piper was also a talented quilter who discovered her quilting skills almost by accident.

"She thought she was taking a sewing lesson," Joe says. "It turned out to be more than that. She enjoyed it so much that she became active in it and was quite a talented quilter."

A forthright Southwest Philadelphia girl who had no trouble speaking her mind, Gina loved movies (especially John Wayne's), knitting, exercising, and walking and dancing with Joe, her husband since Valentine's Day 1976. She doted on her three granddaughters.

"Mostly, she quilted," Joe says. "She really got into it. She loved it. She took over a room in our house. I called it Bernina-ville (for the sewing machine line). It was jam-packed with quilting materials, machines and accessories."

In January, when Gina Piper lost the seven-year battle she had waged against endometrial cancer, she left an unfinished quilt that several of her quilting buddies decided to complete in tribute to her.

The cream and rustic red Lone Star piece will be raffled during the Sixth Annual Blue Jean Ball. The fundraiser for the Cancer CARE Fund of the FirstHealth Moore Regional Hospital Foundation will be held Saturday, June 6, at the Fair Barn in Pine-

Joe, who calls the quilt "Gina's Star Performance," has written the copy for the card that will detail its features for Blue Jean Ballgoers. In that copy he describes the quilt like this:

"It was likely the most complex and challenging design she had ever worked on ... (It) features the Lone Star pattern, one of the oldest designs in the craft and one Gina had always admired. It's known by other names as well, including 'The Star of Bethlehem,' 'Star of the East' and 'Morning Star.' The pattern features a central medallion, the star, with elements of diamond-shaped fabric to form the star points. While the basic design is an established one, Gina added personal touches that make it uniquely hers."

In addition to her personal quilt-making, Gina also worked tirelessly - making quilts and recruiting volunteers - for Project Linus, a national organization that gives "security blankets" to children in hospitals and shelters.

One of Gina's donated quilts went to a fundraising auction at Academy Heights Elementary School, where it was bought by Dr. and Mrs. Paul Kuzma. Dr. Kuzma, an anesthesiologist at FirstHealth Moore Regional Hospital, knew Gina from his work at the FirstHealth Back & Neck Pain Clinic. Laura Kuzma coordinates FirstHealth's CARE-Net program, which connects trained volunteers with people dealing with chronic illness. She knew Gina as a CARE-Net patient.

Joann Hanley got to know Gina through a Wednesday quilting group at RoseMary Hansult's Quilting Room on Linden Road, where her friends goodnaturedly dubbed her "the queen of scrap."

"She could take leftovers and put them all together beautifully," Hanley says.

The unfinished quilt Gina left behind needed just a little more work, so Hanley, Hansult and Gina's other Quilting Room friends (Suzanne Sullivan, Judy Leslie and Bobbie Marder) each made a square and put them together. Sullivan did the corners before the piece went to a professional in Greensboro for machine finish-layering. Quilting group members did the binding and finishing work when it was returned and now look forward to seeing it at the Blue Jean Ball.



"How should we measure school success?" was the topic for the Thursday, April 2, meeting of the Women of Seven Lakes.

Moore County School Superintendent Dr. Susan Purser led the discussion. With twenty-two campuses serving over twelve thousand students, Purser said Moore County SAT and End of Grade test scores exceed state and national averages, and 91.8% of No Child Left Behind goals are being met. However, while conceptually sound, Purser said NCLB tests are limited to reading and math proficiency and do not fully measure or demonstrate school success.

Later in the meeting, proceeds from the recent Women of Seven Lakes 'Taste of the Town' event were presented to two local non-profit organizations. JoAn Moses accepted a \$3,100 gift for the FirstHealth Cancer Care Fund and Carmela Chase accepted a \$3,100 gift on behalf of the West End Methodist Church Food Pantry. Currently the Food Pantry feeds over 240 local families every other week.

The Women of Seven Lakes next meet on Thursday, May 7, at 1:00 pm at the Seven Lakes North Clubhouse. The Moore County Chapter of the League of Women Voters will present a report on their three-year study of poverty in children in Moore County.



an additional \$773,000 in expenses that are beyond their control. Those cost increases include \$145,000 in support for new elementary and middle schools, \$333,000 in salary and benefits mandated by the state, and a \$295,000 increase in energy, utility, and maintenance costs. MCS has already identified "maintenance decreases, position reductions, and operational cuts" that will make up for that additional \$773,000 in mandated spending, Purser told the Commissioners.

As a result, she said, the zeroincrease request for county funding effectively represents a 3.1 percent cut in local funding.

She noted that the state provides sixty-one percent of MCS funding — and exactly what that funding will amount to remains very much in doubt, as state lawmakers and Governor Beverly Perdue wrestle with their own funding shortfalls.

Cuts to education funding in the governor's budget would result in a \$2 million reduction in funding for Moore County, Purser said. A budget proposal in the Senate would cut twentyfive to thirty teachers, as well as other positions, and a House proposal could result in even deeper cuts.

Commissioner Jimmy Melton thanked the schools for "understanding the condition this county is in. We are still strugglng also."

"I don't think you are going to find that this board is going to ask you to do anything that we won't do ourselves," Commissioner Tim Lea added.

Jail, Public Safety Building will be on May 4 agenda

During County Manager Cary McSwain's report at the end of the Monday, April 20, meeting, Commissioners discussed how to forward the decision making process regarding siting and design considerations for a new detention center, public safety building, and administration building.

Earlier in the afternoon they had visited the county-owned Carriage Oaks Shopping Center with representatives of consultants LandDesign, to explore the suitability of that site for the new administration building. The county's planning and inspection departments, department of social services, and wellness center are already located in the converted storefronts of the shopping center.

"The one thing that came from LandDesign is that there is land enough there to build the building," based on the parking and zoning requirements imposed by the Town of Carthage, Commissioner Lea said.

Chairman Nick Picerno said the committee that had worked with architects to develop the space and facilities requirements for the administration building should be reconvened to provide input to the Commissioners on site selection.

"We're going to get one shot at this," Picerno said. "I want to do it right. I think, to do it right, we need to get that committee back in action and give them the same opportunities and goals that we did with law enforcement . . . I'm not sure we have had that process with the governmental center."

A key decision point is whether to build a two-story jail.

A committee formed to study

the issue recommended a twostory detention center during the April 16 Work Session, but that choice could add \$500,000

to \$1 million to the cost of the project.

"We have to be accountable for (See "Commissioners," p. 22)

(Continued from front page) in The Times does not answer the petition."

"We have more people who want to sign," Horne added. "What percentage will it take for you people to take notice?"

President Ron Shepard explained that the Board had taken the concerns of the petitioners into account in upping the number of free passes.

Jim Embler echoed Horne's question about how many peti-

tioners it would take to get the Board's attention.

"When it comes up next year, I guess we are going to have to have a petition of everyone in here," Embler said. "You have 60% now."

Horne asked which members of the Board had voted to approve the new policy — and to modify it in the April 20 Work Session. Shepard said the decision was unanimous. Horne then asked how the membership

could go about recalling the sitting Directors. He was asked to read the bylaws.

"The only issue on the petition was about the children and grandchildren," Horne said.

"Why does a grandchild weigh more than a guest from New York," Shepard replied.

"We can stand here all night and I don't know that we are going to change anything," Shepard replied, at which point Horne called the Westside President "arrogant."

Shepard struggled to maintain an orderly discussion, as residents opposed to the new pool policy tried to engage the Board in debate about the issue and other residents called for order. To make matter more complicated, members who wanted

to address the pool issue were interspersed at the mic with others with completely different concerns. Several current and former Board members also offered thoughts on the new policy.

Among the comments:

- Linda Horne asked what the policy would be this Summer for use of the Westside Pool by North and Southsiders. Shepard replied that members of the Seven Lakes Landowners Association would be able to use the pool as guests, having paid the quest fee.
- Ann Marie Venancio asked why special guest fees attached to the pool and not to the tennis courts or lake. She objected to the expense of implementing the Board's plan to hire someone to check folks in and out of the

pool.

- Both Shepard and Vice President John Hoffmann called into question the notion that the petitioners represents a majority of members. Hoffmann said there are 1718 member lots, and assuming that most are owned by a couple, that potentially represents more than 3,400 people. The nearly 600 signatures on the petition would the represent a little more than fifteen percent of the membership, he said.
- Hoffmann also argued that every amenity has its own cost/usage profile. A relatively small percentage of members use the pool, he said, but it is very expensive to operate. So it makes sense to attach a user fee to it. "The policy we have approved is

every dollar we spend," Commissioner Lea said. "If we are going to save \$500,000 [with a one-story structure], then we need to do that."

Robbins Water

County Manager McSwain asked the Commissioners for guidance on the next steps to take in talking with the Town of Robbins about upgrading its water treatment plant and reservoir to provide an additional source for the county water sys-

tem.

McSwain noted that Robbins had received a report, prepared by McGill and Associates, on the cost of bringing the mothballed water plant back into operation.

After some discussion the Commissioners agreed to invite the Town of Robbins and other interested parties to a May work session devoted solely to the issues surrounding Robbins and Moore County cooperation.

Tuesday, May 12, was suggested as a possible date for the meeting.

(Continued from page 22) absolutely fair, and I won't change my mind on user fees," he added.

- Bob Horne questioned Hoffmann's logic on user fees, noting that the Board has not budgeted any significant income from user fees at the pool.
- Kay Haggard suggested the Board had made its decision in the absence of any data on pool usage. She suggested they return to the 2008 swim season policy and gather usage data before making any change.
- · Mick Herdrich pointed out that he has two grandchildren, but also seven nieces and nephews who are as dear to him as grandchildren - and should not be treated differently. "This is an equality issue," he said.
- Former SLWLA President Mary Anne Fewkes explained that the policy of allowing nonresident children and grandchildren to use the Westside pool without paying a guest fee is only two years old - something the Board two years ago tried as "an experiment."
- Former Recreation Director Betty Milligan said the result was "more children than you

could ever imagine," including many "grandchildren," who were clearly not grandchildren. "The problem was the dishonesty of some people who live here," she added. "I was on the Board. I saw it."

At the end of the meeting, Legal Director Ed Silberhorn told the crowd he was disappointed in the tenor of the discussion, "because I feel people aren't wanting to be civil." Noting some instances of name-calling and raised voices, he said, "I am really disappointed tonight in the way this discussion has been conducted."

Other business

In other business during the April 28 General Meeting:

- Shepard reported that the Lake Auman Sprots Club had cleaned up the dam and cove areas, as well as Pine Knoll Island. He encouraged those who visit the island to take anything they bring with them back when they leave.
- Treasurer Kathy Kirst said the Association has sold two of its brokered CDs — at a premium - in preparation for cutting a

\$200,000 check in May to go toward the remediation of the Lake Auman Dam.

- · Director Herdrich said the work on the remediation of the dam should be completed by mid-May. Silberhorn noted that the community has a ten-year bonded warranty on the work.
- · Community Manager Joan Frost said the Association office will be open to process member dues payments from 3:00 pm to 7:00 pm during the weeks of May 4 and May 11.
- Infrastructure Director John Goodman said he is looking for volunteers to serve on one of three committees:Landscape maintenance, Roads & Drainage, and Capital & Special Projects. He encouraged anyone with expertise or an interest in those areas to contact him at 400-
- Security Director John Hoffmann said he will be working to strictly enforce those rules

(Continued from front page) seed as early as possible and it would be beneficial to us to contract this work," Fulcher said.

Reciprocal Agreement

Zielsdorf reported minor changes to the West Side Letter of Agreement that were mainly for clarification of content rather than policy decisions.

After discussion, the Board agreed to modify the section pertaining to outdoor recreation to exclude the stables.

A discussion on updating the guest fees policy was tabled until the May Work Session.

Committee Appointments

Melinda Scott, a resident since 2006, was appointed to the Architectural Review Board [ARB]. Temporary members Mike Cummins, Mark Widman, and Edie Starkey were unanimously approved for permanent status.

Judicial Committee members Dean Charles, Ed Chapman, Frank Krohn, Carolyn Follansbee, and Dave Kinney were also approved for permanent status.

Dues Collection

Twenty-eight accounts, representing approximately \$51,000 in delinquent dues, were turned over to the Association lawyer for collection, Fulcher reported.

Property owners were given thirty days to comply before fore-

closure proceedings begin.

Fulcher said that, of those contacted, seventeen or eighteen property owners have not responded. Four of the properties are improved with residences, of which two are already in bank foreclosure proceedings.

"Most of these accounts are lots and most are on the South-side," Fulcher said. "They go back to when a number of lots were purchased under time-shares. There may be more owed than what they are worth, but we'll need to do some title searches before we can do anything further with them."

Immediately following the Open Meeting, Zielsdorf called a Closed Meeting to discuss two properties

Road Shoulder Mowing

Road shoulders in front of residences will continue to be mowed only if the property owner requests the service, reported Director Bud Shaver.

"The point is to minimize the amount of mowing. Landowners also should recognize the mowers we use have safety features that do not allow for a quality cut," Shaver said.

Zielsdorf clarified that the mowing policy changes only apply to residential areas. All common areas will continue to be maintained and mowed on a regular schedule.

Recreation

Director Bruce Keyser, Jr. announced that new playground equipment would be ordered the first week of May and that the committee had met and discussed future issues and programs. Recreation Committee members are Laura Douglass, Amanda Keller, and Tammi Smith. Keyser said anyone else interested in joining was welcome.

The Spring/Summer Recreation bulletin is available at the SLLA office, reported Assistant Community Manager Chad Beane.

He reported the Easter Egg Hunt was very successful, with approximately 150 children participating.

An upcoming trip to IKEA in Charlotte is scheduled for May 15. Space is limited, so please call the office at 673-4931 for more information.

The NC Open Water Swim will be held on Lake Echo May 29-30. Both the lake and dam will be closed for the day, and over 375 swimmers from around the state are expected. Spectators are welcome.

Horse camp and soccer program registration are underway.

Beane also announced that Jill Hartsell, the very popular art teacher from West End Elementary School, will head up the SLLA Summer Day Camp program. Full and half-day options are available.

Seven Lakes native Ed Hill will manage the pool. "He grew up here and competed at NC State. Hill is very talented and very experienced." said Beane.

He reported that pool maintenance projects were right on schedule and the pool would officially open on Saturday, May 23.

Finance

Director Denny Galford expressed his appreciation to the community for approving the dues increases.

"The two years dues increase gives us the opportunity to do some financial planning," Galford said.

He also thanked his committee members, Jerry Grout, Gil Jones, Ed Sanchez, and George Temple. He reported the committee will be following the same financial policies implemented this past year: "It will be business as usual."

Meeting on April 28, the committee discussed a number of issues related to the SLLA survey; however, Galford said no action was taken.

He said an inventory of all assets, including those valued under \$2,500, would be completed in January, immediately following Fulcher's retirement. "I hope that those interested will pick up copies [of the document] and understand that the Finance Committee and management did follow adequate procedures," said Galford. "There has been publications indicating we didn't have written bids or follow procedures."

Maintenance

"The yard debris site is for yard waste — it's not a place for garbage, or lumber, or used railroad ties!" exclaimed Director Bud Shaver. "It takes time and money for our people to go in and dig this stuff back out. Please, please, it's only for yard waste."

Shaver said each member of the Maintenance Committee was given a brief orientation on procedures and equipment. Members include Mike Cummins, Mike Pennington, Andy Smitley, and three members from the former Lakes & Dams Committee, George Stahl, Jim Allen, and Don Truesdell.

Fulcher reported that maintenance staff was completing many smaller projects including work around the gates, road shoulders, and painting.

Community Standards

The Community Standards Committee held an organizational meeting on April 13, reported Director Kent Droppers. Members are Ray Pardue, Nancy Blythe, Nancy Welch, Charles Peterson, Mary Ellen Krohn, and Lucy Ingram. Additional members are welcome and encouraged to join.

Droppers said the committee discussed hosting twice annual open house meetings to assist landowners with frequent questions and issues. He also said the tracking spreadsheet that lists violations was tweaked to provide a more complete historical documentation of repeat offenders, and that violators will now first receive a telephone call rather than a letter.

"This is less confrontational," Droppers explained.

He also said the committee is exploring a "three strikes you're out" type clause that would fast-track repeat violations to the Judicial Committee for resolution.

Other changes include having

Roving Security Patrol report violations that occur over the weekend and reviewing boat and boat trailer rules and regulations.

Security

Director Gary Caulk reported Security Committee members are retired School Resource Officer William Cullifer, Detective Brian Edwards of the Town of Southern Pines Police, and Lt. Mike Tew of Pinehurst Police.

Five new gate guards are in place and Caulk asked residents to be patient as they learn procedures.

Community Manager Report

Fulcher reported revenues, as of end of March, were ninety-eight percent collected. However, expenditures are expected to go over budget, estimated at 104%.

"There have been no budget amendments made this year and the Board approved several capital projects," reported Fulcher. "There will be some increase but not too much over what we anticipated."

Dues statements were mailed last week and Fulcher said over \$100,000 has already been collected.

Drainage Project

Repairs were made to an underground drainage pipe located on Hastings Lane. Originally estimated at \$75-\$85,000 to replace the existing pipes with two new 36" pipes, Fulcher said the maintenance department was able to install a new sleeve for \$4,500.

"It didn't make the drainage any less or any better but this [repair] will last ten to eighteen years

Fulcher said there is an ongoing drainage problem at this location and eventually will need more substantial repairs.

Other Items

Chemicals will be added to the lakes the week of May 11. More information will be available in the Interlake and posted to the community bulletin boards.

Open Meetings of the SLLA Board will be held the last Wednesday of the month, with Work Sessions to be held on Monday mornings, sixteen days prior. Exceptions to this schedule include no Work Session in November, and December meetings on December 7 and 16.

The Board unanimously approved the recombination of lots 2178 & 2179, as lot 2178.


