

State cuts not as bad as feared

It's a mixed blessing: the NC General Assembly's budget would leave Moore County Schools [MCS] with nearly \$4 million more in funding than was initially feared.

But that still means Superintendent Dr. Susan Purser

es for employees.

Board of Education Chair Laura Lang told the Commissioners that MCS will have to use \$4 million in fund balance to cover cuts for the coming fiscal year and asked the Commission-

has \$8.2 million less to work with than last year, and dozens of MCS employees may receive pink slips in the coming week. Altogether, 120 positions — about half currently vacant — are being targeted for elimination.

"Our entire staff has worked diligently to save money," Purser told the Moore County Board of Commissioners during their Tuesday, June 7 meeting, "in order to meet this day of reckoning."

MCS will also be consolidating bus routes, closing offices for an additional fifteen days next year, and, for the third consecutive year, making do with no salary increas-

ers to keep this in mind when working on the County's budget. Because the state budget is set for two years, MCS has a reasonable estimate of what cuts are expected next year.

The School Board came to the Commissioners in April asking for \$3.1 million in additional local funding to make up for some of the cuts in state funding that were anticipated. However, the final state budget — which has been approved by the House and Senate but not yet signed by Governor Beverly Perdue — does not pass down worker's compensation

Lakers' water use climbing

It's hot. It's dry.

And daily water use in Seven Lakes just crested the 800,000 gallon mark.

800,000 gallons per day is the target Moore County Public Utilities uses for the voluntary water conservation measures the county requested of its utilities customers in 2008 and has never formally lifted. Seven Lakes has been inching toward that number for the past several weeks, as high temperatures started rise above 90 and the rain dried up.

Despite some nice rainfall in March and April, it's been nine months since Seven Lakes had an above-normal

amount of rainfall, according to Public Works records. Even with near normal rainfall of 4.6 inches in March, the community is still nearly six inches short of normal rainfall for the year and more than five inches short over the past twelve months.

The fact is, this time of year, Seven Lakes uses as — or maybe more — much potable water watering its lawns as it does for drinking, brushing teeth, and flushing the toilet.

Wells in Seven Lakes once supplied all of the community's water needs, but only three remain in operation now, contributing about 120,000 gallon per day to the supply on a peak day.

The rest passes through a pump station in front of West Pine Middle School, pulling water from Pinehurst through mains that run along NC Highway 211.

When Seven Lakes uses 800,000 gallons per day, those pumps are running for about 19 hours out of every 24, continually refilling the two water tanks that together hold 300,000 gallons.

Running flat out, 24 hours a day, the system can deliver 1.1 million to 1.2 million gallons per day.

"But I've got another trick up my sleeve," Moore County Water Operations Manager Ben Vaughn told *The Times*. Vaughn has a long history (See "Water," p. 21)

Sheriff's officers raid Currie Mill Rd pot farm

Two Currie Mill Road residents were arrested by Moore County Sheriff's officers on Friday, June 3, in a drug bust that netted \$68,000 in seized drugs and shut down an indoor marijuana farm

less than a half mile from Seven Lakes West.

Gary Moore Strickland, Jr., 29, and Crystal Genevieve Strickland, 28, were arrested on numerous marijuana manufacturing, trafficking,

and possession felonies, as well as with misdemeanor child abuse.

The raid was part of a joint

marijuana plants growing in a greenhouse behind the Strickland residence at 707 Currie Mill Road, along with another

22 plants growing inside the residence.

Also seized were numerous items of paraphernalia used to grow marijuana, including lights, fans, filter, fertilizers, and containers. Officers also seized approximately 964 grams of processed marijuana from inside of the residence, 8 dosage units of Alprazolam prescription pills and \$334.34 in U. S. currency.

During the joint operation officers located and seized an additional 20 marijuana plants growing behind two different residences on Serene Road near the Eagle Springs community. Charges are pending in these cases.

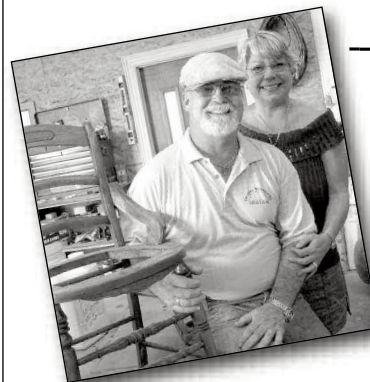

Extra landscaping charges raise concerns

A vote of acclamation during the Wednesday, May 25, meeting of the Board seated Northsider Andy Lowe to oversee security concerns for the Seven Lakes Landowners Association [SLLA] Board of Directors. Lowe joins recently-appointed Director Bruce Keyser, Jr. in filling chairs left vacant by veteran Directors Chuck Mims and Melinda Scott, who both resigned shortly after the March 2011 annual election.

After Lowe took his place at the table, the Board settled down to a businesslike meeting perturbed only by some pointed questions directed at Community Manager Alina Cochran concerning the cost of recent beautification projects undertaken by Davenport Landscaping.

In February, on a controversial 4-2 split vote late in the term, Davenport was awarded a \$146,000 contract to perform landscaping and mowing services for the Association. However, the Board stopped short of approving an \$11,980 optional enhancement contract also recommended by Davenport for additional plantings, instead tabling that decision to allow the incoming Board an opportunity to weigh in.

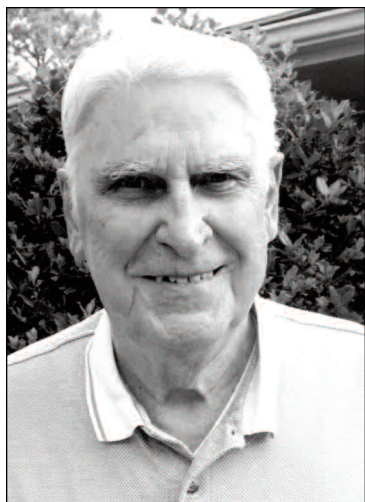
Yet Davenport has been busy during the past two months enhancing the appearance of the entrance gates and other common areas — and quickly praise from both Board members and residents in recent meetings.

But, during Wednesday's meeting, the concern centered on who, when, and under what authority the decisions were made to authorize this additional work that falls outside the approved Davenport contract.

Current financial policies allow the Community Manager to approve budgeted expenditures up to \$3,000 without Board approval. During her management report, Cochran explained that funding is in place for these types of landscape improvements

and that she authorized nine individual beautification projects with Davenport, each coming in under the \$3,000 mark, for a total cost of \$10,797.

"The community has an aging look and we must constantly budget for beautification," said Cochran, noting that, in the past, the Seven Lakes Garden Club had purchased and installed flowers

at the entrance gates.

Cochran further explained that the original Davenport contract recommendation had been for \$39,000 in additional services, but the Board had agreed to budget only \$12,000, primarily anticipated for planting, fertilizing, and seeding work.

Describing a similar example of recently authorized projects, Cochran said she approved roof repairs at the stables and the North Clubhouse. The projects were separate and issued at different times, each came in under her \$3,000 spending limit, yet both were performed by the same contractor.

In addition, Cochran noted that the fiscal year will conclude with an excess of \$163,506 in the general fund, which will be rolled into reserves set aside for the road paving projects and state-mandated dam repairs.

During a short but tense discussion at the Board table over Cochran's signature authority for expenditures, SLLA Treasurer Conrad Meyer said he was aware of the concern and that the

Finance Committee had already initiated a review of the existing policy.

"When Dalton [Fulcher, the former Community Manager] was here, he had a page that laid out what he could sign for and under what circumstances," Meyer said. "That document still exists, but it and the Talis Management contract don't match. We need to revisit this and come to an agreement, so there won't be any debates in the future if the Community Manager went beyond her authority."

SLLA President Bob Darr agreed and said it was an issue that he and Meyer would be working on with Talis representatives in the near future.

Volunteers sought for Beautification Committee

In a related discussion on improving community appearance, Darr said he is actively seeking a chairman and volunteers to serve on

beautify our community," said Darr, who volunteered to work with the group.

Also during the meeting, Grounds & Maintenance Director Keyser said he has met with Davenport staff and is pleased.

"I think our grounds are looking good," Keyser said, "and I'm looking forward to seeing what

else they can do to make our community shine."

Part-time Northside resident Elaine Wilderson also complimented the improvements.

"I like the sprucing up with flowers and other things that are growing," she said. "I really appreciate it and think

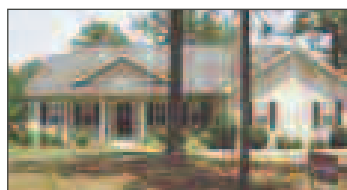

Sandhills Winery starts 7 Lakes Farmers' Market

Farm fresh eggs, pasture-raised poultry, natural grass-fed beef, specialty cupcakes, handmade baskets and jewelry, Amish bread, and a cornucopia of fresh vegetables and fruits are just a sampling of the many exciting things waiting to be discovered each week at the new Seven Lakes Farmer's Market, sponsored by the Sandhills Winery.

"This is a community thing. A market for our community because we deserve it," said Winery owner Leslie Rose. "We're about showcasing the talents of the people in our community, giving our residents a place to visit on Saturday mornings, and also

helping local farmers bring fresh food right here to Seven Lakes."

With a radius extending approximately fifty-miles in each direction, Rose explained that she has been in contact with farmers not only from Moore County, but also Lee, Richmond, Scotland, and Montgomery Counties as well.

Backyard gardeners are welcome to set-up a table, said Rose.

"If you have some extra squash or tomatoes, give us a call. We're also looking for crafters and artists and people in the community that make wreaths and friendship breads" she said.

And local non-profit organizations, clubs and churches

are invited to sign-up to sell coffee & tea on Saturday mornings as a fundraising event.

Table space may be reserved for a nominal fee to cover advertising costs. All excess monies collected will be donated to local food banks.

"Food feeding food," said Rose. "This has become a fun thing, but it is also another way we're giving back to the community."

Each week, the market will feature a diverse and eclectic mix which will follow the seasons, as Rose hopes to continue the Farmer's Market through the Summer and into the late Fall.

Just in time to celebrate the Sandhills Winery first anniversary at their location on Seven Lakes Drive, Rose said creating and coordinating the Farmer's Market has

been a labor of love.

Working with local Realtor Linda Criswell, Deanna White from Candor, and Craven Hudson, a resident of Seven

Lakes North who serves as Director of Moore County's Extension Service office, Rose said she began exploring the

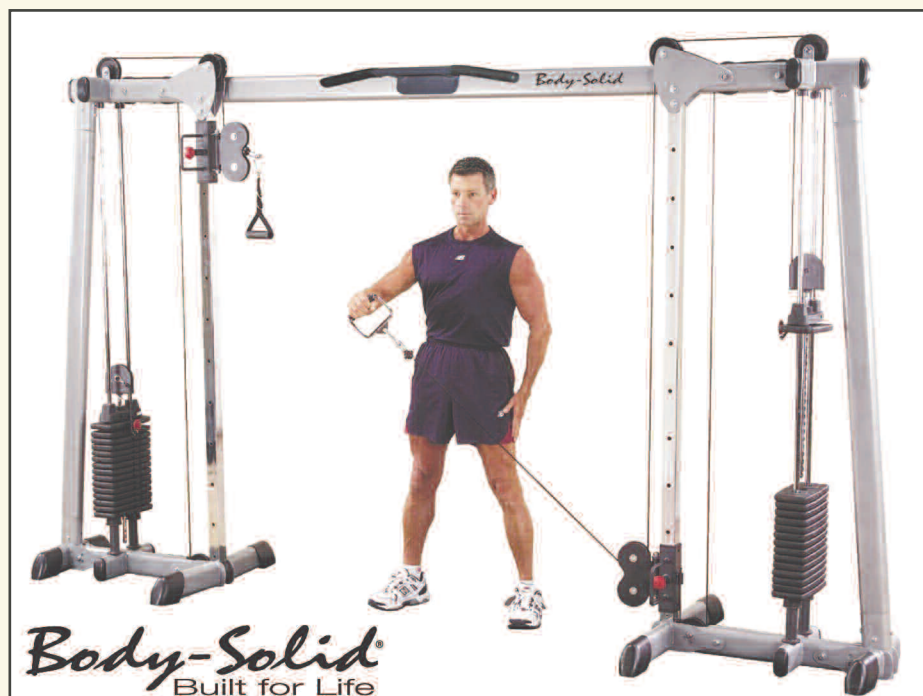

Jo Nicholas elected President of state League

Well-known in the Seven Lakes community as a go-getter and natural leader, Westsider Jo Nicholas recently extended her time and talents to the state level as President of the North Carolina League of Women Voters [LWV].

Elected at the organization's state convention in Raleigh last May, Nicholas has served on the NC-LWV Board of Directors for two years and continues to serve as League President of the Moore County LWV chapter, a position she has held for six years.

A retired teacher and school principal, she explained that her professional experience in education, conflict management, and working with people have been valuable skills which complement the League's mission as a non-partisan political organization that encourages informed and active participation in government, works to increase understanding of major public policy issues, and influences public policy through education and advocacy.

The League neither supports nor opposes candidates for office at any level of government, but instead works to influence policy through advocacy.

Currently, the League has 900 state and local chapters,

including nineteen groups in North Carolina.

Nicholas said, as president, she has set a personal goal to visit each and every state chapter.

"I am hoping to reconnect the local chapters with the

state," she said. "I want to make the NC League more accessible to local chapters and their endeavors."

In addition to presiding over quarterly meetings of the state League and weekly visits to her office in Raleigh, Nicholas also hopes to bring together the presidents of each chapter once or twice a year to share ideas.

"We're beginning to get on the map in terms of things that are going on right now in North Carolina," Nicholas said. "We're looking at redistricting and anticipate the

General Assembly looking a new lines in July. It may upset some of them [legislators], but it is for the betterment of the people."

Nicholas said another top priority of the NC League is researching a method of gas extraction called "fracking."

According to a NC League report prepared by Audrey Albrecht of the Lower Cape Fear chapter, fracking involves using high-powered steam underground to push out oil from shale, thereby ruining everything in its path, including underground aquifers.

While Nicholas agreed that alternative sources of fuel must be explored, she said currently the discussion on fracking tends to be lopsided. With potential extraction sites in this region of North Carolina, fracking may become a major issue at the local level, and the Moore County League has responded by planning a panel discussion

later this year to consider the pros and cons of such activities.

In addition, Nicholas said a priority for state and local leagues is the upcoming 2012 election season.

"We want to make sure people understand that voting is important," she said, noting that later in June she will travel to Washington, DC, to meet with LWV representatives from across the nation. One particularly helpful service of the LWV is their production and distribution of nonpartisan voter guides that provide biographical information on each candidate.

Looking ahead to those elections, Nicholas said the Moore County chapter completed a redistricting study of Moore County two years ago and will meet in August with the Board of Commissioners to offer their recommendations.

"We looked into it and found that our districts were not

equal in representation and voters," she told *The Times*.

"When you have a discrepancy, you want to redraw the lines to get each district equal," explained Nicholas. "We hope, before the 2012 election, that the new districts will be representative."

An active member of the League for only eight years, Nicholas said she became interested in the organization shortly after moving to Seven Lakes West.

"I had heard about the League a long time ago, but I thought it was a bunch of little old ladies — but it's not!" said Nicholas. "I was invited to a meeting and enjoyed it. There was a lot of stimulating conversation and informative presentations: I joined immediately."

Nicholas said it is exciting to get involved and reach out to local politicians, especially here in Moore County where the League is strong and well-respected.

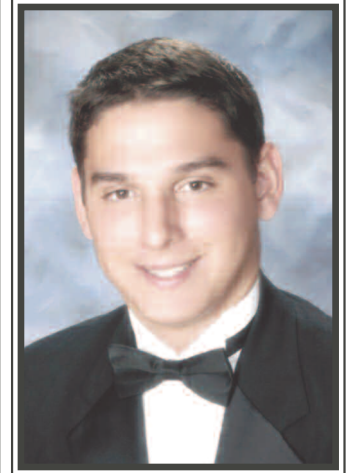

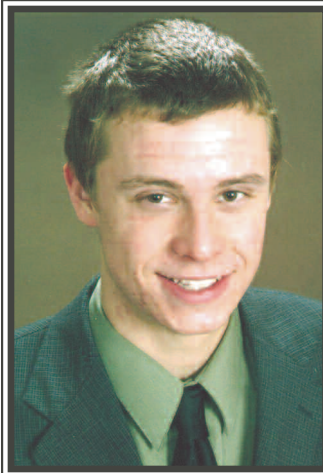

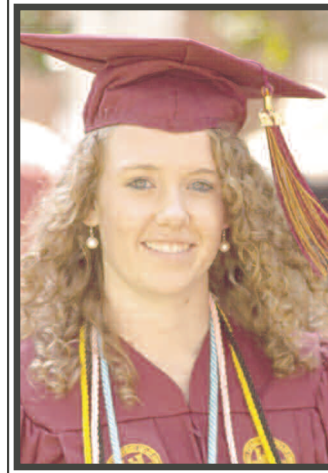

It's storm season. Is your family prepared?

Along with the warmer weather, blooming gardens, and greening trees that welcome Summer comes an increased threat of severe storms, tornadoes, hail, and flash flooding.

This year, in particular, has seen significant storm-related destruction, with over fifty tornadoes reported across the nation, including a deadly twister in neighboring Lee County that killed two and caused an estimated \$57 million in property damages — though some have indicated the total cost could reach \$100 million.

While the financial toll was high, relatively few residents lost their lives because of one simple fact: the storm occurred during daylight hours.

"There is a direct correlation between storm death and destruction and the time of day," explained Scot Brooks, Emergency Manager for Moore County Public Safety. "Lee was a daytime tornado, and the majority of citizens were aware of the danger, because of broadcasts [tornado warning alerts]. A

tornado is so random that everything we do is more of a response to it than a pre-planned reaction. A tornado is much more difficult to deal with."

Unlike the Plains states, where severe storms are more common, Moore County does not have a system of horns, bells, or sirens that would alert residents of impending danger. Moore County does have an emergency telephone notification system; however, this program is predominately used for targeted populations affected by flash flooding or a hazardous materials spill.

Phone numbers in the system are culled from the Emergency 911 system, but you can also submit your cell phone number to receive these alerts. Go to Public Safety on the Moore County website at www.co.moore.nc.us and click the red telephone icon.

"It is very quick and works well, but the system is not quick enough to notify people for things like tornadoes,"

said Brooks.

Instead, Brooks recommends several important planning steps that you can take to help your family prepare for an unexpected emergency or severe storm.

DUCK —

*Down to the lowest floor,
Under something sturdy,
Cover your neck and head,
Keep in shelter until the storm has passed.*

Foremost is to purchase a NOAA [National Ocean and Atmospheric Administration] weather alert radio. Most are relatively inexpensive and function like a standard AM/FM alarm clock. The difference is these radios are programmed to broadcast National Weather Service alerts, any hour of the day.

"They would wake you up at night to let you know of a hazardous condition, like tornadoes, severe weather,

or a flood," Brooks explained.

One note of caution when purchasing a NOAA radio from a non-local source or retailer, such as the internet, is that it may not be programmed to this area's alert

house, away from doors and windows. If you do not have a basement, evacuate to a closet, interior bathroom or beneath a stairwell and crouch down. If you are in a vehicle or mobile home, you should seek immediate shelter in a public building or more substantial structure.

An easy acronym to remember is "DUCK:" Down to the lowest floor, Under something sturdy, Cover your neck and head, Keep in shelter until the storm has passed.

Each family should also assemble a 72-Hour kit with water, non-perishable foods, sanitation supplies, first aid kit, waterproof matches, flashlight and batteries, and copies of important personal documents. If you have children, elderly family members, or pets in the home, you will need to make additional preparations. A comprehensive

In addition to the local chapter's work on redistricting and researching the issue of fracking, the group is also currently studying the Federal Government's role in education and how funds are allocated in Moore County Schools, as well as looking at maladaptive behaviors in the classroom and whether intervention programs are available as needed.

And while the issues and legislative priorities of the organization change over time both at the state and local levels, the League's constant focus is its goal to make democracy work for all people.

"I am doing this for my girls and my grandchildren," said Nicholas, "I want to leave a legacy for them."

sive list of recommended supplies is available at www.ready.gov

Discuss with your family at least two meetings places: one directly outside your home for immediate disasters, and a second place outside of your neighborhood in case you are away when a disaster occurs and are prevented from returning to your home. Also select an out-of-town relative or friend who can serve as a communications point for your family. It is often easier to make long-distance phone calls following a disaster than to reach a local number.

"If a disaster occurs, stay put," Brooks advised. "Stay off the roadways, and limit cell phone communication to emergencies. Contact your loved ones; and then get off the phones quickly, so emergency responders can use the frequency."

He noted that in Lee County, the cell phone circuit was overloaded for over an hour. It was impossible for emergency responders to get from one point in the city to another, because so many residents were on the roads immediately after the storm passed.

"It really hampered the emergency services response, plus it was dangerous," Brooks said. "We had major power lines down and gas leaks. The populace was just coming out to view the damage, but they were putting themselves in harm's way."

By sheltering in place and then staying put, citizens allow professionals and trained volunteers to assist those where there is the most need.

Moore County is benefited by an active CERT [Community Emergency Response Team] program with teams based in Seven Lakes West and Foxfire Village, in addition to Aberdeen, Southern Pines, Pinehurst, and Woodlake.

"We are in direct commu-

nications with CERT teams," Brooks said, "and, in their specific area, they would process and implement aid and then communicate that information back to us. They are trained and have equipment and lots of things that could help in the recovery process. Depending on how bad a disaster could be, it might be hours or even days before county responders could reach you."

Brooks noted that, in Lee County, there were areas that received no assessment or care for twelve hours.

There are other volunteer opportunities available to assist with disaster planning and preparedness, including the Moore County Chapter of the American Red Cross, the Medical Reserve Corps, and Moore County Amateur Radio Services [MOCARS], who serve as a communications partner with the county.

According to Brandon Vin-

cent of the National Weather Service office in Raleigh, the most active season for tornadoes is March, April, May and June, followed by October and November. The most frequent time of day that tornadoes occur is mid-afternoon to early evening. Here in North Carolina, the vast majority of tornadoes are ranked on the Enhanced Fujita scale as F0-F2; though the Lee County disaster was a high F3 tornado.

The peak for damaging winds from severe thunderstorms occurs in June and Vincent noted that straight line winds in excess of 80 mph can be as destructive as a tornado.

Peak hail distribution occurs in May and he suggested that golf ball-sized hail can also be as damaging or even more so than tornadoes.

North Carolina ranks number two in the nation for light-

ning-related deaths, a figure attributed to the natural topography and the many outdoor recreational pursuits that are popular, including beach activities and golfing.

"The general rule is: If you can hear thunder, you can get struck by lightning," warned Vincent.

However, the number one weather-related killer across the nation is flash flooding.

"People die because of flooding more often because of bad decision-making," Vincent said. "Water is very powerful. Don't make the bad decision to cross a flooded roadway. Even slow-moving water at six inches is enough to push a vehicle off the road."

with Moore County water and Seven Lakes in particular, having kept the Seven Lakes system running before the county acquired it.

Vaughn explained that he is currently negotiating with suppliers who could install a larger impeller in the NC Highway 211 pump station. That could add another 144,000 gallons per day to the production capacity.

More Water from Robbins?

On the more distant horizon, Moore County continues to ponder options for bringing additional water to Seven Lakes from a second direction: down NC Highway 705 from Robbins, down NC Highway 211 from Candor, or along a couple of routes from Randolph County.

The Commissioner have expressed a strong interest in partnering with the Town of Robbins to include both its water customers and the Seven Lakes customer base in the currently-languishing Northwest Moore Water District, which has voter-approved access to \$16 million in borrowing capacity that could be used to lay water lines and build a new water treatment plant on a reservoir in Robbins.

While the citizens of Robbins seem hopeful about that plan, the Town Manager seems skeptical, the Town Council is non-committal, and, until Robbins makes up its mind, there's not much

reason for the Board of Commissioners to poll Seven Lakerers to see what they think about the idea.

Conservation 'triggers'

For now, Seven Lakerers can depend on about 1.2 million gallons of county water each day, and, even though the community has passed the 800,000 gallon milestone for the first time this year, it's unlikely to hit 1.2 million. The most the community has ever used in one day is 906,996 gallons, back on July 1, 2009.

Without rain, however, the county could, at some point in the Summer, be forced to impose mandatory conservation measures. The recently-revised Water Conservation Ordinance uses a number of "triggers" to determine when conservation measures kick in — and how onerous those measures need to be. Among the triggers are the drought status of the Moore County, the water level in Drowning Creek, and the static water level in the underground aquifer that supplies most of the county's water, measured at several of the system's wells.

Wells in the Pinehurst area are far more productive than wells drilled in Seven Lakes, and the county depends on a network of Pinehurst wells for the bulk of its water supply. It also has water purchase contracts with the towns of Aberdeen and

Southern Pines, both of which impound surface water in reservoirs. Moore County Public Utilities also buys Harnett County water through the East Moore Water District.

Vaughn told *The Times* that the water level in the aquifer "has a few feet to go" before it would trigger mandatory conservation measures. Meanwhile, the county is currently in "moderate"

drought, with "severe" drought gradually creeping across the map from the east.

Those with an interest and a little computer savvy can monitor both the drought status and the water level in the aquifer on the internet.

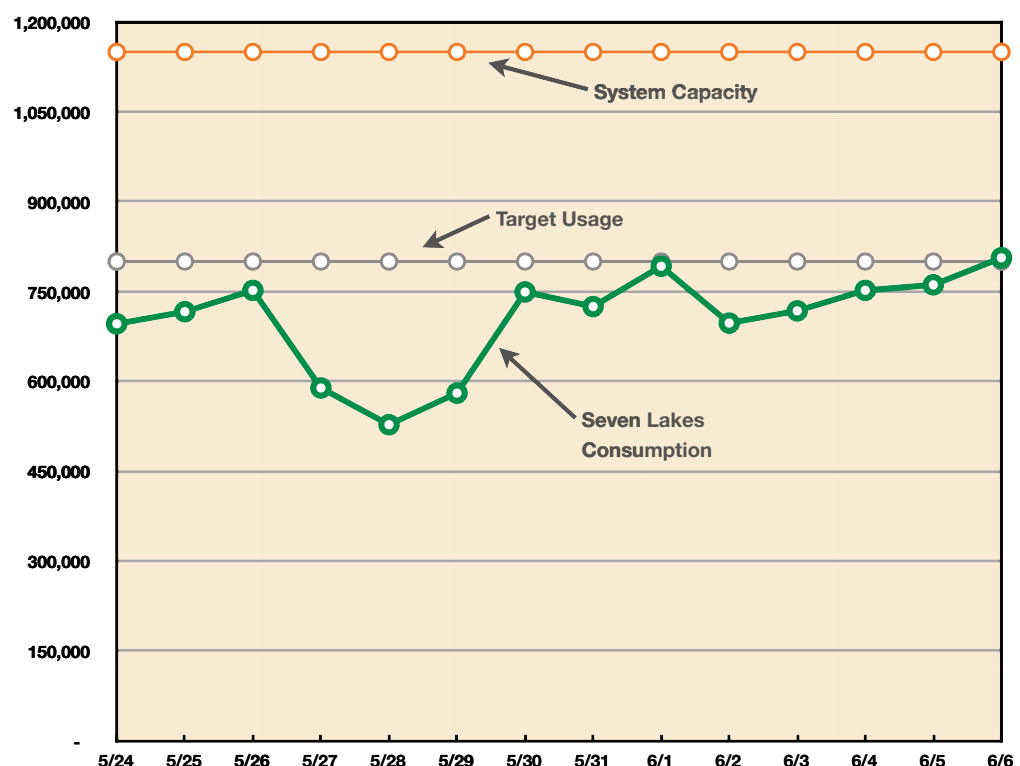
The NC Drought Monitor (at www.ncdrought.org) is updated every Thursday. The site provides a county-by-county map of the state that reflects the drought status

of each county, from no drought through severe drought to exceptional drought.

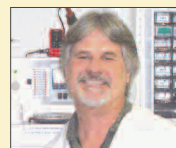
Seven Lakes Water Consumption

tainly changed since I first became a minister. Over the past thirty years I have presided over dozens of weddings; and I

can count on one hand the number of couples, young or old, who, if they were not sharing the same house, they were sharing the same bed.

You have already answered

the only question I ask: "Are both of you committed to spend your life together and to make that commitment before God and in the presence of witnesses?"

In this country marriage is first of all a civil affair and constitutes a legal contract for the protection of both parties. If a minister or rabbi presides, he or she is acting as an official of the state and certifies the marriage by signing the license.

If the couple chooses to have a religious ceremony, the minister does not actually "marry" them but only serves as a witness who gives God's blessing to the union.

When two people make a lifetime commitment they are then married in the sight of God whether or not a minister is present. Your question implies that you have already taken that step and now wish to acknowledge it publicly and legally.

To ask you now to live apart for a year before you publicly acknowledge your marriage is an unrealistic request. This is not the time to punish you for living together, but a time to celebrate your love and commitment to each other.

You ask if I would marry a couple who is living together. My answer is: "Gladly!"

After participating in hundreds of weddings — including my own and my children's — over fifty years as an ordained minister, I do have a word of advice.

I have watched parents inflict serious harm on their

costs, tort claims, and an additional \$3 million in cuts to Moore County.

As a result, the \$3.1 million initially requested from the County is no longer critical to balance the MCS budget.

Noting that Governor Perdue has ten days to either veto or accept the state budget as it currently stands, Commissioner Larry Caddell said Moore County's representatives in Raleigh feel confident that the budget will stand.

Commissioner Tim Lea said he would like the Board to consider trying to find some budget cuts in an effort to save some of the 120 school system positions targeted for elimination.

Chairman Nick Picerno has also requested some changes to the budget — though nothing that would give additional funding to the schools.

The Board is expected to vote on the FY 2011-2012 budget during their June 21 regular meeting

Visitor's Bureau Tax for Airport Repairs

The Board of Commissioners on Tuesday evening approved a request to the General Assembly that would

amend the 1987 Local Act that allows Moore County to levy a room occupancy tax on hotel visitors. Under the amended act, the County will, four times a year, remit net proceeds of the occupancy tax to the Moore County Convention and Visitors Bureau. The Visitor's Bureau will then use at least two thirds of the funds remitted to promote travel and tourism in Moore County. The remaining funds will be used for tourism-related expenditures.

The Commissioners are asking the Visitor's Bureau to use seven percent of the net proceeds of the occupancy tax to repay the county's \$250,000 local match obligation on a Federal Aviation Administration grant for improvements to the Moore County Airport — as well as an even larger local match that could be needed if another pending grant is approved.

In essence, the county is fronting the money for the local matches, but the Airport will ultimately repay the county using funds from the occupancy tax. Commissioner Tim Lea proposed that a two percent interest rate be applied to the \$250,000 County match; however, the Board voted 4-1 in favor of

the request without incorporating Lea's suggested change.

Commissioner Comments on Water District

Responding to comments made by the Robbins Town Manager during a Town Hall Meeting on the county's proposal to include both Robbins and Seven Lakes in an expanded North West Moore Water District [NWMWD], Chairman Nick Picerno said that including Seven Lakes in the reconfigured district would represent an investment by the County in the District, just as including the Robbins infrastructure in the District would be an investment by the town.

The Commissioners agreed that looking to Harnett County and Asheboro as alternative sources of water for the District would be beneficial. Commissioner Tim Lea said the county is on a "ticking clock," and needs to have water options so that the \$16 million in funding for the NWMWD project is not lost.

MMC Textile Relocation

The Board approved a

request made by Moore County Partners in Progress Executive Director Ray Ogden on behalf of MMC Textiles LLC, a subsidiary of McCoy-Ellison, Inc to relocate from Monroe to the former Carthage Fabrics building in Carthage.

The relocation, expected in the next three months, could bring eighteen jobs to the area and expand the tax base by \$250,000. The County will pay \$10,000 to help with the relocation.

According to Ogden, money would not be paid to the company until nine jobs are created and retained for one year and the capital investment of \$250,000 is established. The Century Committee of Carthage has also

pledged \$10,000 toward the relocation.

Fire Department and Rescue Squad Merge

The Board approved a request by Public Safety Director Bryan Phillips to terminate existing contracts and approve a contract with the Village of Whispering Pines Fire Department to provide Medium Duty Rescue and Medical First Response within their fire district. Whispering Pines Rescue Squad has previously provided rescue and medical response within the squad's district, which includes the Whispering Pines Fire District.

In order to create a more efficient operation, the two

departments have merged to create the Whispering Pines Fire Rescue Department. Whispering Pines Fire Department has received all equipment and personnel necessary to meet the requirements and certifications as a Medium Duty Rescue provider and Medical Responder with the NC Association of Rescue and EMS and the NC Office of EMS.

Amateur Radio Week

Responding to a request from Jim Johnson of Seven Lakes West, representing the Moore County Amateur Radio Society [MOCARS], the Board declared June 20 – 26 as Amateur Radio Week.

Moore County has more than 135 licensed amateur radio operators, who provide public assistance through emergency radio communications free of charge. The organization works closely with the emergency services and the health department.

Amateur Radio Field Day will take place June 25-26 at Aberdeen Park. Johnson thanked the Board and invited all to attend the field day.

County Hiring Freeze Exemptions

In May, the Board of Commissioners approved a hiring freeze requested by Commissioner Craig Kennedy. However, during Tuesday's meeting, the Board approved several exemptions to the freeze, including: a resource compact operator in the Solid waste department; a custodian and two technicians in Property Management; and a water pollution control plant operator in Public Works.

County Manager, Cary McSwain presented the Board with a request to consider funding a Budget Director Position for the County that would have a salary of \$73,000 a year. The Board did not vote on the matter, but will discuss it further to see if eliminating financial consulting work could help pay for such a position.

Chairman Nick Picerno noted that, if the position is

added, the finance department would be receiving a forty three percent increase to its budget in two years. That increase includes \$1 million spent on an enterprise resource planning [ERP] system two years ago.

Planning Matters

The Board on Tuesday held one public hearing and called another for June 21 on a \$70,000 grant through the 2011 Individual Development Account CDBG program. Moore County Planner Tim Emmert explained that the program began in 2009 with a two-phase commitment made by the Board of Commissioners in partnership with Northern Moore Family Resource Center.

The Board approved a request by Emmert to award one bid and one housing rehab contract for \$8,600 to M.S. Thompson Rentals. This is the second to last home the County is committed to

serving under this grant program.

As requested by Commissioner Craig Kennedy, Emmert presented the Board with detailed information relating to the function of the Community Development Process, the applicants to the program, and those served. Twenty-nine applicants requesting aid have been served under the Community Development Process.

Inmate Healthcare

The Board approved a request by Chief Deputy Neil Godfrey to amend Southern Health Partners contract for medical care services to inmates at the Detention Center from \$177,000 to \$180,000.

The per diem per inmate rate will remain the same at \$1.75 per inmate per day based on 130 inmates. The County has budgeted inmate services at \$200,000 for next year. Southern Health has

provided health care to inmates since 2006.

Other Business

In other business at their Tuesday, June 7 meeting, The Board of Commissioners:

- Approved a request by District Attorney Maureen Krueger for a cash match of \$9,800 for a Governor's Crime Commission Grant. The District Attorney's office was awarded a \$150,000 grant from the Governor's Crime Commission for an investigator and a victim/witness advocate for a two year period.
- Approved Chief Financial Officer Carrie H. Neal's request to finance the purchase of two roll-off trash trucks from Triple T Parts & Equipment Company, with

\$244,000 in financing from BB&T.

- Approved the continued use of Simmons and Simmons Management to provide grinding services for yard debris and leaf and limb material.
- Approved CAL-FLO Lime Slurry from Burnett Lime Company at the Addor Water Pollution Control Plant.
- Appropriated \$1.2 million for the radio read meters project.

it makes the whole community look better.”

Northsider Rich Scott, husband of former Director Melinda Scott, also expressed respect for Davenport's work and questioned the intentions of the four freshmen Board members that were seated in the Annual Meeting election: Darr, Meyer, and Directors Don Fentzlaff and Bob Racine.

“You ran on a uniform platform and agenda that criticized the previous Board and said you were committed to two things: One, get rid of Davenport and two, get rid of Talis Management Group,” said Scott.

Continuing, he noted that since being seated, Darr had indicated that Davenport was doing a great job, an opinion Scott shared, and he anticipated that a review of Talis and Cochran's performance would yield a similar result.

“I felt you were quick in terms of your comments,” he said. “I'd like to recom-

mend that you evaluate things before moving to judgment.” He added that Director Bud Shaver showed foresight in his comments early in the process that the Board should check performance before making a rash decision.

“We can't afford to pay people and have a disproportionate amount of time spent on supervision and paid benefits,” Scott said. “I am a supporter of outsourcing and have seen some positive things as a result of them.”

Darr responded that the election campaign waged by the four incoming Directors stated their interest in a critical review of Talis Management — not a desire to end the contract.

“We did not run by saying that what we are after is to get rid of Talis,” Darr said. “We said we want to look at whether we're getting a bang for our buck. And that is ongoing as we speak . . . and I expect will be ongoing as long as Talis is here, which could be forever. They are here, they are our managing company, and our job is to evaluate that and make them the best they can be. That is the best we can ask for.”

On the Davenport issue, Darr said the incoming Board had reviewed the contract and determined that it is solid and cannot be undone unless the contractor fails

to meet their obligation.

“The only way to go back to not having Davenport is if they screw up,” Darr said, “and they are obviously not doing that. My issue was dollars — not their performance.”

Finance

Treasurer Meyer distributed a preliminary year-end balance sheet, noting that information is not complete as all accounts had not been updated and closed out. In addition he said that accumulated depreciation had not yet been adjusted.

Any excess monies left over from the current fiscal year are automatically rolled into the reserve fund set aside for next year. Cochran estimated that rollover would amount to \$163,506.

Cochran said she used a “buffer account” set up by the previous Finance Committee to cover unforeseen expenses last year, including the roof repairs at the stables and North Clubhouse, new window casings at the Clubhouse due to termite damage, and resurfacing and re-striping the basketball court.

In a quick summary of budget variances, she noted a decrease in salaries for security and maintenance, reflecting outsourcing decisions made last year that were off-set by increases to

contracted services. There was also a variance noted under repair and maintenance expenses related to a theft incident.

Continuing the financial report, Meyer said the committee reviewed the member collection policy initiated by the previous Board and has received feedback from the Association's attorney. The policy will be presented for discussion at an upcoming Work Session.

Looking ahead, Meyer said he will be meeting with Talis representatives to specifically discuss a few ongoing financial issues.

“It's nothing critical,” he explained, “more just a discussion about how we will handle some things in the future.”

Architectural Review

The Board voted unani-

mously Wednesday night to appoint former Director Donna Stephan to serve on the Architectural Review Board [ARB], a committee that she previously chaired. Stephan resigned from the panel in early 2008 following a flap with her fellow Board members over a published statement in *The Times* concerning who should determine the fate of the five-acre old driving range owned by the Seven Lakes Country Club.

While that land has remained vacant over the last few years, the Club announced early in 2011 that a buyer for the tract had been identified and, in February, an amended agreement between the Association and the Club was signed.

In nominating Stephan, ARB Director Don Fentzlaff

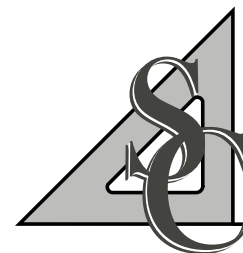

explained that she has volunteered to recuse herself from any negotiations or votes related to development of the old driving range, if necessary.

Stephan will replace long-standing ARB member and former Director Sally Kindsvatter, who is moving to Ohio in June.

"We are sorry to see Sally go," said Fentzlaff. "She has always been on top of everything, and we will miss her help. We wish her well."

In the previous month, ARB granted approval for one new siding project, a new roof, a garage addition, a house repainting project, and conditional approval was given for construction of a new home. In addition, ARB denied two applications for insufficient information.

Lakes & Dams

Murky water continues to be a visible concern at Echo Dam, but the issue may be more cosmetic than problematic, reported Director Fentzlaff.

He said that vegetation has been cleared from the site and water samples taken and sent to S&ME for analysis.

"They don't think feel it is a major problem at all, and we hope to get final results from them very soon," Fentzlaff said.

SLLA President Darr agreed and said S&ME is exploring whether a catch basin that is full of silt and located higher on the dam could be causing the cloudy water. If so, he said, the fire department may be able to assist in blowing debris from the catch basin.

Continuing his report, Fentzlaff thanked the members of the recently reformed Lakes & Dams Committee for their work, particularly in taking piezometer readings over the last two weeks. Those members are Les Sommers, George Temple, Rodney Godwin, Jean Alfano, Mike Pennington, Jim Allen, Vince Ulrich, Don Truesdell, and Fentzlaff.

He explained that regular piezometer readings help

determine a baseline of the water level in each dam.

"The readings looked pretty good compared to S&ME readings taken earlier this year," Fentzlaff reported. "I really appreciate the committee going around and testing these dry wells. It was very hot and we put in a heck of a day to complete all the readings."

He also noted that lake water quality was tested this month, though results have not yet been received.

The Lakes & Dams Committee is continuing discussion about installing a sign detailing boating rules at the Lake Sequoia boat launch.

Later in the meeting, Director Keyser reported that several buoys near the Sequoia Beach area were sinking. In discussion, the Board recommended a review of an approved map of buoy locations that has been used successfully in previous years.

Recreation

Summer recreation and programming is kicking into high gear with SLLA Day Camp, Horse Camp, Seven Lakes Sting Rays Swim Team, swim lessons, and more all on track for the coming months.

"Alina [Cochran] has done a great job and put together a terrific bulletin of recreational activities," reported Director Bob Racine.

The Northside Pool opened for the season on Friday, May 27 at 3:30 pm, adhering to an abbreviated schedule until June 13. The recreation

bulletin includes a comprehensive listing of pool hours. The bulletin is posted in the community mailrooms, available at the SLLA office, and will be distributed by email.

The Seven Lakes Sting Rays Swim Team is back this year under the direction of Coach Barbara Keating, beginning June 6. Twice a week practices will be held Monday and Wednesday, 7:00 - 8:00 pm, and Tuesday and Thursday, 10:30 am - 11:30 am. Resident cost is \$60 per child, \$40 any additional; Non-resident cost is \$75 per child, \$55 any additional. In addition, swim lessons begin June 13 with beginners on Tuesday and Thursday, 9:30 - 10:30 am, and intermediate on Monday and Wednesday, 6 - 7 pm.

Water aerobics will be held Monday through Friday, 8:30 am to 9:15 am. There is no charge to attend.

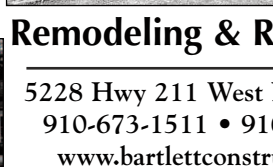

that is growing through the tiled surface on the tennis courts.

Cochran responded that a work order has been issued and noted the problem is difficult to control because the slab underneath the tiles was not adequately prepared when the new surface was installed.

In a related discussion over the fading color of that surface, Keyser recommended caution that the weed killer utilized did not further damage or fade the tiles.

He said the company who installed the tile had been contacted and they said the fading was due to the sun and there was nothing they could do about it.

"They didn't stand behind their product," said Keyser.

Racine encouraged any members with new ideas for recreational events or those interested in serving on the Recreation Committee to attend the next meeting, scheduled for Wednesday, June 1 at 9:30 am.

Community Standards

A draft of a new, more user-friendly inspection form that will speed up the process of reporting violations has been under discussion by the Community Standards Committee, reported Director Racine. In addition, he said the committee is also recommending extending the grace period to correct alleged violations from seven days to fourteen days.

Looking for input, Racine took a straw poll of members present at the meeting, asking whether they would prefer that first contact noting an alleged violation on your property be in written letter form, as is the current policy, or through the more personal contact of a telephone call, as was the previous policy.

Reserve Study

Director Bud Shaver reported he completed a proposed cluster plan approach to paving that recommended

initially paving secondary roads in a given area, then the primary roads, which would prevent unnecessary damage to the main arteries as different areas were paved.

He recommended the next step is for the Executive Committee of the Board to meet with a paving contractor prior to selecting an engineering firm that will provide consulting services during the bidding and construction phases of the project.

Shaver said that some of the roads will require heavy asphalt replacement, while others only need an overlay of new pavement.

He also recommended that any paving project should include a realignment of the entrance gates with dedicated turn lanes from each exit.

Communication

Continuing in his ongoing effort to improve communications with members, SLLA President Darr said he has reviewed how information is disseminated in the Seven

Lakes West community and is looking for a chairman for a communications committee. In particular, he noted the Westside has a system that is useful in generating emergency messages to all residents.

In addition, Darr encouraged residents to attend the monthly Work Session and noted that significant discussion is held during those meetings and public input is welcome.

The next SLLA Work Session will be held on Monday, June 13 at 7:00 pm at the Game Room; and the SLLA Town Hall meeting will be held on Monday, June 20 at 7:00 pm at the North Clubhouse.

Fire Hydrants

Special thanks were extended to the Seven Lakes Fire Department for their work in repainting the communities fire hydrants.

Speaking to *The Times*, Firefighter Steve Cox explained that all fire

hydrants in the Seven Lakes business village, and Seven Lakes North and South were painted bright red.

"We wanted to give them a more uniform appearance, and it makes them easier to spot," said Cox.

In addition, fire hydrants are also marked by blue reflectors in the roadway which make them easy to locate when it is dark.

Other Business

In other business on Wednesday, May 25, the SLLA Board:

- Accepted the resignation of Judicial Committee member Ken Keating and unanimously appointed Jane Lowe to serve in his place. Director Shaver drew attention to a possible conflict of interest since Lowe's husband serves on the SLLA Board of Directors; however, no comment or concerns were raised. Dick Weber was appointed as an alternate member of the Board.

- Heard from Darr that

mediation of a legal matter required immediate action and a Closed Session of the Board was called last week. "We met and made a decision . . . I am not at liberty to tell you what the legal concern was about, but the issue has been almost entirely resolved," reported Darr, noting that some paperwork was still in process.

- Heard from Darr that a new public address system was purchased for the North Clubhouse. He thanked Director Lowe for his assistance with the project.

- Heard from Shaver that Cochran has been in contact with the NC Department of Transportation to reinstall the blinking safety light along Seven Lakes Drive. He also thanked her for compiling a reference library of rules and guidelines that the Board must follow to comply with state regulations.

- Tabled an approval of meeting minutes pending a more comprehensive review by Secretary Racine.

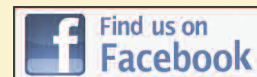
