Fred Lawrence, Visionary

Fred Lawrence, who dreamed of, and then built, Seven Lakes, died on Friday, February 19, at age 84.

Lawrence was a highly successful insurance broker from Sanford who, the story goes, was quail hunting in the area that would become Seven Lakes when he recognized its potential for development.

He assembled investors, formed a corporation — Longleaf, Inc. — and, in 1972, purchased the land that would become Seven Lakes North. The tracts that would become Seven Lakes South and Seven Lakes Country Club were added in 1974; Seven Lakes

SLLA Board prepares to eliminate lifeguards

As The Times went to press on Wednesday, only one more vote was needed to do away

with lifeguards at the Northside swimming pool for the coming swim season.

During their Thursday, February 25 Work Session, the Seven Lakes Landowners Association [SLLA] Board of Directors voted to forward to the Thursday, March 3 Open Meeting President Chuck Leach's motion "to authorize management to obtain a pool manager and attendants for the 2016 season."

The Open Meeting is scheduled for Thursday, March 3, at 7:00 pm.

During the Work Session, Director Bob Racine presented the Recreation Committee's recommendation that the Board continue to employ lifeguards from noon to 5:00 pm during the Summer school vacation, while extending pool hours from 6:00 am to 9:00 pm.

The pool would be operated on a "swim at your own risk" basis during hours when no lifeguard is present.

The Recreation Committee proposed reserving 6:00 am – 8:30 am for adult only swim, with water aerobics from 8:30 am to 9:15 am.

Swim lessons would be offered from 9:30 am to 11:30 am and the pool would be closed for maintenance from 11:30 am 'til Noon.

Lifeguards would be employed from Noon to 5:00 pm. At 5:00 pom, the pool area would be cleared, as lifeguards were replaced by pool attendants, who would remain on duty from 5:15 pm to 9:00 pm.

Schedule too complicated

Leach, who has been a consistent opponent of retaining lifeguards, objected that the proposed schedule was too complicated.

Voters will need photo ID at Primary Election polls

It's Primary Election season, and this year is already proving to be a doozy.

If the Presidential Primary weren't enough to persuade you to turn out to vote on March 15, there are several important local races and ballot questions that deserve your attention.

- There's a GOP primary race for state Representative that pits incumbent Jamie Boles against challenger John Zumwalt;
- Former Whispering Pines Mayor Bob Zschoche and Former Southern Pines Mayor Frank Quis are competing in the GOP primary

to replace Randy Sanders building, 707 Pinehurst on the Board of Commis-Avenue in Carthage, and will continue through Saturday.

- There's a request from the County to add one-quarter cent to the sales tax rate, to help pay for new school construction.
- And there's a request from the state to borrow \$2 billion to fund a variety of capital projects across the state, including at state parks and community colleges.

Voting early

March 15 is Primary Election Day, but, if you'd prefer to avoid the lines at your polling place, you can vote early in either Carthage or West End.

One-Stop absentee voting began on Thursday, March 3 at the Board of Elections building, 707 Pinehurst Avenue in Carthage, and will continue through Saturday, March 12. Hours are Monday-Friday 9:00 am to 6:30 pm and Saturday 9:00 am to 1:00 pm.

One-Stop Voting begins at the Old West End Gym on Tuesday, March 8 and runs through Thursday, March 10, from 11:00 am to 6:30 pm all three days.

Bring your Photo ID

The most important thing to know about voting this year is that you will be asked for an acceptable photo ID, Moore County Elections Director Glenda Clendenin told *The Times*. That might be an NC Drivers License or ID Card, a US Passport, a

New SLLA Manager is a people person

Spencer Ferguson is a people person. His broad smile and easy laugh telegraph that fact

as soon as you walk into the office of the new Seven Lakes Landowners Association [SLLA] Community Manager.

A native of Greensboro, Ferguson majored in Education at the University of North Carolina - Greensboro. But a stint at student teaching persuaded him that his place was not in the class-

So, for twenty years, he has managed communities large and small across North and South Carolina. Ferguson told *The Times* that he has managed communities as large as Seven Lakes and as small as a ten unit townhouse association.

"Some were very similar to Seven Lakes," he said, "with sions." golf courses, pools, gates, and other amenities."

What about the job appeals to him?

"The people," he said. "The different personalities and people you meet with on a daily basis. I like dealing with the people."

"The biggest challenge, the thing I like best, is dealing with the personalities, the

Ferguson has no agenda of his own, he told *The Times*, but sees his job as helping the Board set its agenda, and then helping to make it happen.

"I don't want to come in here and change everything," he said. "Things are aging, of course. Things need to be maintained to keep up people's property values. Money is and always will be an issue. We need to maintain the value, but be responsible in doing so."

Every community is different, he explained.

"I've had it where they want me to make all the decisions, and I've had it where they don't want me to make any decisions." he said. "I've even had situations where every member of the Board resigned - so I had to make the deci-

Over the years, Ferguson said, he has seen a decline in community involvement folks being willing to serve on a board or committee.

"Families are having to work two jobs, and after work they need to stay home and watch the kids. So, even though their home is their biggest investment, they don't get involved the way they

"When they get home at 6:00 pm, they don't want to think about these kinds of things."

Ferguson is new to CAS, Inc., the company that provides management services to the Association, but he said he has known people from CAS through the indus-

He's also been getting acquainted with Seven Lakes and with his new home in Foxfire Village.

"I've eaten at every restaurant in town," he said. "Everywhere I go, people engage you in conversation. And when they find out what I do, then they really start to engage."

"When I do go into restaurants and shops, everyone

seems to know everyone else. In the Food Lion parking lot, all the cars have barcode stickers."

"I'm glad to be here — honored to be here," Ferguson said. "Everyone I have met

has made me feel welcome."

"I hope to help the Board, the staff, the homeowners, the committees — I hope to help them enhance the community and its amenities."

Beacon Ridge Country Club sale in limbo

A possible deal for the purchase of Beacon Ridge Country Club has apparently fallen

through.

Club owners Don & Rhonda Billings are considering their options, while planning to continue to operate the Club in the meantime.

The Club was listed with broker Hilda W. Allen as an auction sale initially scheduled to be concluded on February 4.

But, when a potential buyer approached the broker with an offer outside the auction, the date was pushed back to February 16. A letter of intent was signed, with a formal contract pending

In a February 22 letter to the Club membership, Billings said the buyer "suffered a sudden and devastating loss of a close family member."

Allen recommended cancelling the auction, and Billings agreed. The realtor and auction company then announced that the auction was cancelled because the property was under contract.

"I understand that a couple of days after the death of the potential buyers' family member," Billings wrote, "he talked with a representative of the real estate company and said he would get back later regarding the purchase. So far, he has not."

"I therefore assume that he is no longer a potential buyer," he added.

Ending the letter on an upbeat note, Billings writes, "the resodding of the greens has greatly improved the condition of the course, and BRICO [the Billings' company] will continue to operate the Club and provide to its members and customers all the benefits of a full service country club."

Billings and his wife Rhonda came out of retirement to run the club in 2013, after terminating a lease with Wingfield Properties, which had operated it for sixteen years.

Since then, the Billing's company, Beacon Ridge Investment Group, has made substantial upgrades, including remodeling portions of the clubhouse; adding a fitness center; reopening the pool; which had been closed by the county Health Department; and bringing on longtime Foxfire Golf manager Howard Cannon to manage day-to-day operations.

The improvements helped reverse a decline in membership. Billings told The *Times* that the club currently has just under 200 memberships, with the majority of those including couples or families.

Cobb objects to trailer storage expansion

Infrastructure Director Parks Cobb objected strongly to the expansion of

of Seven Lakes West's boat and trailer storage area, currently underway, during the Tuesday, February 23 Seven Lakes West Landowners Association [SLWLA] Board Meeting.

The \$20,000 project was developed by an ad hoc committee led by Community Manager Jeanette Mendence, with the objective of relieving overcrowding in the existing facility. The Board approved the project in January; Cobb was not present at that meeting.

The project will expand the storage area to the northeast, onto land already owned by

the Association, providing he said. room for fifty-five larger, pullthough spaces, capable of accommodating larger boats or RVs. Removing those larger items from the existing yard is expected to allow reorganization of that space.

Cobb argued that the Association should have explored purchasing one of Moore County's former well sites, located at the intersection of Longleaf and Smathers Drives, which would provide a "straight shot" to Johnson's Point.

He also said the expansion is destroying two acres of planation-planted longleaf pines, ideal for the production of pine straw.

Cobb said purchasing and spreading pine straw costs \$6 to \$9 per bale, while it can be bailed for \$1.25 per bail, at most.

"It is massively different,"

Cobb said the two acres of plantation longleafs could likely supply the community's need for pine straw, "if we don't completely destroy this

Adding that the project is that the project was not sent destroying a portion of the Westside nature trail, he said, "I think it is a bad idea, and I think we should stop that project immediately."

He also objected to the fact

Buyer surfaces for Stonehill Pines property

There may be life in Stonehill Pines, yet.

Mayor Mick McCue reported that news

to the Foxfire Village Council's Thursday, February 25 Work Session, reporting that a prospective buyer of the nearly 1,500-acre property is interested in resurrecting the project.

The property failed to sell at auction late last year and is currently listed by Robert Edwards of Edwards Real Estate.

McCue said he met with Edwards and a local representative of the prospective buyer, who asked that the Council renew the expired Stonehill Pines development agreement.

News of a major development north of Foxfire Village on Hoffman Road first surfaced in March 2008, when a Florida-based company purchased the 1,442 acres for nearly \$20 million.

The proposed development was to include two worldclass golf courses, a resort hotel, more than one thousand homes, and up to 90,000 square feet of retail space.

Having never before contemplated such a large development, the Village rewrote its Zoning Ordinance to include a category for Planned Unit Development [PUD] and eventually annexed the Stonewall Pines tract.

But Stonewall Pines was a victim of the recession that began in late 2008, and financial backing for the project disappeared, never to be recovered.

The development agreement between the Village and the original Stonewall Pines developer was renewed year-after year, but finally expired on December 31.

McCue said the new developer simply wants that agreement extended and, at this point, does not anticipate major changes in the development plan.

The most significant change would be to scale back from two golf courses to one, McCue said. He added that the developer felt the price points originally projected for the residential unit were "a little high."

Financing for the development is apparently to be provided by California-based Senaste Capital, LLC, which McCue described as a one-person investment firm.

Village Attorney Robert Hornick is currently exploring whether it is possible for the Village to renew the development agreement for an unnamed buyer, McCue said.

"I hope that he will tell me

that's possible," McCue said.

County asks state to restrict new tax revenues

In Moore County, the March 15 Primary Election Ballot includes

a question asking voters to authorize a quarter cent increase in the sales tax.

Moore County's Board of Commissioners have already pledged to use the revenues generated by that tax increase exclusively for to pay for school construction projects.

Now they are asking the NC General Assembly to pass a law ensuring that future Boards will honor that pledge.

The Commissioners approved a resolution during their Tuesday, March 1 regular meeting that calls on the General Assembly "to pass a local act for Moore County restricting use of proceeds from the additional one-quarter percent . . . Sales and Use Tax . . . to Moore County public schools construction needs including the debt service associated with construction and to, further, include a sunset provision on the local act if the need for Moore County public school construction and debt service for the same ceases."

Commissioners Chairman Nick Picerno said he had spoken with NC Senator Jerry Tillman about the proposal, and Tillman was in favor of

approve the new quartercent tax.

The quarter-cent, which amounts to an extra 25 cents on a \$100 purchase, is expected to generate additional revenue of \$2.2 million per year.

Moore County Schools [MCS] and the Commissioners have agreed on four top priority projects that, taken together, have a price tag of \$119 million: new elementary schools in Aberdeen, Southern Pines, and near Whispering Pines, and a new Career-oriented high school to be built near Sandhills Community College.

Once those projects are finished, however, six additional projects that could easily double that \$119 million expenditure are waiting in line.

In related action, the Commissioners put in place a process for making sure the new sales tax takes effect as soon as possible after it is approved by the voters.

The Board will hold a special meeting on March 31 to pass a resolution levying the tax, which will allow it to be collected beginning on July

The Commissioners also passed a resolution establishing a process for paying for school construction proj-

sales tax revenues, if voters ects. Rather than having MCS pay invoices related to the projects, those invoices will be presented to the Board of Commissioners and paid directly from the County's coffers.

> That is similar to the procedure in place for County funding of MCS's digital learning initiative, Chairman Picerno explained.

> He added that it allows the County to recoup any sales tax paid on the projects, providing additional revenue that can be put back into school construction.

the meeting, to point out problems with a different sales tax, one approved by the General Assembly as part of the FY2016 state budget.

Legislators approved an expansion of the types of transactions to which sales tax applies, including many types of labor and installation services, including auto repair, appliance repair, and similar activities. Revenue from the sales tax expansion is limited to use for economic development, public education, and community colleges.

The proceeds from that expansion — expected to total \$84.8 million this year —

> One of the key elements in this year's budget debate was a drive by many rural counties to have local sales taxes allocated to counties based on population, rather than point of sale.



Dudley Crawford named Pastor Emeritus

On Sunday, February 14, the Rev. W. Dudley Crawford, pastor of West End Presbyterian Church for twentytwo years, was named Pastor Emeritus recognizing his work and tenure at West End Presbyterian Church.

Elder Bill Price spoke about the many accomplishments Reverend Crawford had during his years of service. A

framed copy of the resolution approved by the Session was presented to Rev. Crawford.

An historical booklet written as part of the 2012 Centennial Celebration noted that in the late 1970s that as development began in the Seven Lakes community many retirees came to the area from the northeast and midwest.

The calling of Rev. Crawford as pastor in 1983 was the beginning of an era of expansion for the church with a membership of 500 by the year 2000. These new members along with their West End neighbors brought a rich heritage and diversity to the life of the church.

Rev. Crawford's enthusiasm and energy brought about an expansion of staff, programs and facilities. With the addition of a Director of Music and Education, the Christian Education program expanded beyond Sunday morning classes to a weekly after school program for elementary children and an active youth group.

Mission work became a focus as youth and subsequent adult teams have traveled many times to Chetumal, Mexico to work on the construction of a church campus located there. A local effort, Tuesday Tutoring, was initiated to help Hispanic children at West End Elementary School. The church joined the Family Promise network of churches providing food and shelter to homeless families in Moore County.

All these programs were started during Rev. Crawford's tenure and are still in place today. The significant growth in membership at the church resulted in an expansion of facilities. In 1993, the sanctuary, built in 1922, was enlarged and an education and administrative wing was added. Seven years later, a large activity center was built. It was renamed later the Crawford Center in honor of Rev. Dudley Crawford's tenure and work for 22 years.

Hatfield began the quilt in early 2015, and after completing the appliqué embroidery, her friend Cathy Kirk,

the Quilting Cowgirl in Cary, but she also won the Capital quilted the piece. Kirk then convinced Hartfield to enter the quilt in the State Fair in October.

Not only did Hatfield win third place in her division,

Hatfield believed she was the worst in the class; and, when they asked if she would complete the design, her answer was no.

However, she worked out the design at her home and decided to give it her best effort to complete the design.

"I always pick the hardest project," she said.

After many months and much determination, a masterpiece was made.

Hatfield made sure to notify the Elegant Stitches that she did, in fact, complete the "Jazzilicious" design. Elegant Stitches was thrilled and informed her that, to their knowledge, she was the only one from her class who had fully completed the design.

Although Hatfield is a first generation embroiderer, her family supports her work, making requests for quilts for their homes.

Hatfield has even made a quilt for her daughter-inlaw's California King size bed at her request. No matter how big the project, she finishes what she begins.

"It becomes a challenge,"

she said.

Hatfield's current project is making a King/Queen size quilt for her granddaughdaughter, who was married in October. This quilt will have embroidered flowers incorporating purple, the color from her wedding.







In order to explain how the new revenue was allocated among counties, Picerno read from a NC Association of County Commissioners Q&A on the sales tax expansion.

"The specifics are covered under legislative confidentiality and have not been shared with the public or the General Assembly at large," the document read. "Rep. David Lewis explained on the House floor that the percentages were chosen to assist approximately the same counties that would have seen a revenue increase from a 50/50 distribution plan" – that is, a plan that would have allocated half of local

sales tax revenues based on population and half on pointof-sale.

Lewis represents Harnett County in the General Assembly, and Harnett County received the largest allocation of new tax revenues under the plan.

Loan refinancing approved

Also during their Thursday, February 25 Work Session, the Village Council approved three resolutions refinancing the Village's three outstanding loans, moving them from BB&T to First Bank, at a lower interest rate.

The largest of those is the nearly \$1.5 million Woodland Circle Loan. the Village will use roughly \$325,000 of its accumulated fund balance to pay down the principal on this loan, before shifting the remaining \$1.1 million to First Bank.

The new loan will have the same term remaining eleven years — and will have an interest rate of 2.45 percent, down from the current 3.19 percent. That is expected to save the Village \$51,000 in interest payments over the course of the loan.

The \$100,000 remaining on the Village Green loan will have a 2.35 percent interest rate, down from 3.87 perare expected.

have a 2.35 percent interest rate, down from 3.89 percent. Over the eight year term, savings of \$14,000 in interest payments are expected.

Frusco explained that the loan transfers must be approved by the NC Local Government Commission.

Budget matters

Council members discussed in general terms anticipated changes in their departmental budgets for FY2017. Councilwoman Frusco asked that budget requests be submitted by March 15, so that they can be discussed during the March 31 Council Work Ses-

Streets. Don Boito, who handles Streets and Parks. said he will be bidding out the landscaping and mowing contract, with the goal of obtaining a three year agreement with the selected vendor. McCue asked that the bid package include a provision for removal of sand and pine straw from Village streets.

an expected cost of more than \$40,000. Another \$4,000 will be required to clean up some material in the wet areas of the tanks.

Fred was proud of his professional and personal success yet it was a healthy pride and compassion driven by the desire to improve. He certainly contained no form of arrogance or conceit which is a remarkable testament to him, given the level of his success.

I first met Fred in 1970. He had a passion for golf and I managed Quail Ridge was then, as until his death, impossible to know Fred and not like him.

We did a few small real estate projects together in the Sanford area, as he continued to sell life insurance and I managed the golf course. One morning he came into the office and said that he was putting a partnership together to buy a track of land in Moore County.

I don't remember how many people were involved, but somewhere around 125-150 actually bought the Donaldson Tract which ultimately became the base tract for Seven Lakes North.

The story that is told about Fred getting lost hunting and deciding that this would be a great place for a retirement community makes a great story, but as so often in old stories, really does not accurately depict the events as they happened. There were several steps in the process between land purchase and the ultimate plan.

Let there be no doubt, Fred's vision and drive singularly is behind the creation of Seven Lakes. It just took a bit longer to evolve than as the old story goes, but, that is a story for another day.

Today, simply said, without the vision, drive, sales ability, engaging personality, and positive attitude of Fred R Lawrence there would be no Seven Lakes as we know it. Period.

Not many people have the

opportunity to leave something for future generations to enjoy. Fred R. Lawrence was not given the opportunity, he made it.

He made the choice to be a person that would leave his mark in a positive way for those that followed.

He was successful, beyond successful, in making that positive impact.



been shifted into next year's budget, which he called "extremely aggressive."

"The Community needs to express concerns about this project, they need to lobby the Board to stop it, until we can figure out if its actually the right thing to do," he concluded.

Mendence defended the work of her committee, noting that she had kept the Board up to speed on progress in executive session.

She said the committee did consider the County well sites, but they were unavailable at the time.

"Why would we purchase land when we already own the land for this project?" she asked.

Legal Director Silberhorn suggested that Cobb, rather than asking the community to lobby the Board to stop the project, should simply make a motion to do so and see if it receives majority support.

ARB rules revisions

ARB Director Duane Coppeler presented three recommended revisions to the Architectural Review Standards, each of which was unanimously approved on first reading. A second approval will be required before they are formally adopted.

A revision to standard 7.11.1 requires prior written approval from the ARB Committee for the installation and placement of accessory structures, including playhouses, treehouses, doghouses, etc. The existing version of the rule does not give the committee oversight over placement of such structures.

A revision to 7.11.7 requires that garbage containers, AC compressors, mechanical pool equipment and above ground utilities be screened from public view. The revision appears to simplify the existing language without mate-

rially changing it.

A revision to 7.11.8, which requires that propane tanks be buried, adds the requirement that homeowners replacing tanks must show the location of their new tank on their ARB application.

Infrastructure

Infrastructure Director Cobb reported that his committee has three significant projects underway. The first is correcting driveway problems created during last year's repaving project. He said nine residents have provided feedback about problems with their driveway, and the committee has identified three or four more.

In addition, the committee has heard from a number of residents unhappy with the bump in the pavement at the intersection of Wertz and Longleaf.

Cobb said Committee members have met with Riley Paving about correcting those issues. A quote is expected within the week, though the work will need to wait for warmer weather, in May or June.

Striping of the centerline on Longleaf will also need to wait for warmer weather, he said.

Second, the Infrastructure Committee is working to test the quality of the pavement in the Stonegate subdivision before it is accepted as an Association-owned roadway.

Finally, the committee is attempting to identify cracks in side streets that are in

need of repair. Cobb noted that cracks of one-quarter to one full inch are being targeted, because they can be dealt with without taking up pavement and repaving. He asked for assistance from residents in identifying cracks on side streets.

Legal

Noting that it was his last Board meeting, Legal Director Ed Silberhorn briefed the community on a number of issues.

Efforts by the Board and community members to bring the condition of the old Stanly Furniture Plant to the attention of Moore County has met with success, Silberhorn said.

County officials have inspected the site and found substantial problems, including caved in roofs, broken windows, and general dilapidation. The County has demanded that the property's owners deal with those deficiencies or risk having the property condemned.

Silberhorn said a prospective buyer of the recently logged McDonald Family Farms property that lies between Longleaf and the West End cemetery has negotiated with the Board concerning a waterline and utilities easement with the Board, but has withdrawn that request while working out details with Duke Power.

He said the Legal Affairs Committee has been working with Infrastructure to establish ownership of the roads

near Beacon Ridge Country Club, and to make sure ownership is properly reflected in County records and the County GIS system.

Silberhorn said he remains in favor of the spouses of Board members being allowed to serve as voting members of committees, as long as no conflict of interest is involved.

Noting that many current members of the Board are in their first year of service — three have been appointed in the past few months — Silberhorn encouraged the Directors to hold a retreat in order to get to know each other better.

Finance

Director Stan Makson reported that, as of January 31. Association income was just under \$1.52 million and that income was running ahead of budget except for two categories: interest income and lot recombination income.

Expenses were \$1.42 million and running under budget in every category except



A circa 1980 Seven Lakes marketing brochure describes Lawrence's vision:

"When Seven Lakes was conceived, we wanted it to be more than an attractive community with amenities for 'second home' or year-round living. We wanted Seven Lakes to have all of the conveniences and luxuries that we desired for our own families."

"We provided the best talent and materials our money could buy to research, plan, and build Seven Lakes. The end result is the fulfillment of our goal. Our homes and our families are living right here . . . residents in that special world of Seven Lakes."

"We are dedicated to maintaining the high standard that we set in the beginning. We pledge to provide for you the same care and consideration for your family as we have provided for our own."

Those paragraphs were signed Fred & Mary Edna Lawrence.

Providing the best talent and materials and maintaining those high standards, while building what were, essentially, three separate developments meant that Lawrence's enterprise was often short of cash.

The need to bring on more and more investors initially brought unwelcome attention from the Securities and Exchange Commission in 1981.

In 1984, the development was sold to The Moor Group, which promised continued investment, but, in fact, was bankrupt in two years.

In 1986, The NC Attorney General's office opened an investigation into the financial structure of Lawrence's development companies; and, in 1988, he was indicted on securities charges.

Despite those difficulties, Lawrence remained in Seven Lakes, no longer the developer, but consistently honored as the visionary who founded the community.

That early marketing brochure sums up his vision with these words:

"Seven Lakes is more than a resort and residential community, more than a golf and country club."

"Seven Lakes is a self-contained village composed of all the necessities and amenities to provide an uncompromising lifestyle for each property owner."



McDonald's who said you need a roadmap to to decide when you can take your kid to the pool," he said.

Leach argued that it is very difficult to acquire and manage lifeguards — and that employing them only five hours per day would make that task even more difficult.

He also argued against having lifeguards on a part time basis, "for reasons of accountability." Previously, Leach has argued that having lifeguards during only a portion of the day would increase the Association's liability in case of an accident. He has also argued that the Association bears more liability risk with lifeguards than without lifeguards.

Barbara Keating, who served as SLLA pool manager during the 2013 and 2014 swim seasons, urged the Board to continue to utilize lifeguards at the pool.

"During the peak time, when all the kids are out of school, when they are at the pool with their parents, or sometimes without their parents, lifeguards are needed there not just for the safety, but also for supervision," she said.

"When a little kid is running across the pool, and we blow the whistle and say 'Walk.' When they are standing on the Do Not Dive sign and they go diving in. When they cut themselves, and we are administering band-aids and peroxide."

"When an elderly gentleman slipped on the ladder, and he was on coumadin, and he was bleeding profusely, we were able to call 9-1-1 and bandage him up until he was serviced by the paramedics."

"I'm expressing my concern as a former manager and lifeguard," Keating concluded, "that we need lifeguards."

Too little community outcry

Racine's motion to adopt the Recreation Committee's proposal for managing the pool with lifeguards at peak swim periods died for lack of a second.

Leach then made his

motion to proceed without lifeguards, essentially taking the matter out of the hands of the Recreation Committee and turning it over to management.

That motion passed with Leach, Sandy Sackmann, and Mark Gyure in favor, Racine opposed, and Greg Lishawa abstaining. Mark Widman was absent from the meeting.

Lishawa said he had seen little public interest in the matter, compared, for instance, to previous outcry generated by issues surrounding the stables.

"At one point, several years ago, when they talked about closing the stables," Lishawa said, "we had over a hundred people show up at a meeting, and they took that it off the table. I don't see that happening with the swimmers."

"If the silent majority doesn't say anything," Guyure said, "we have to assume that they could care less."

What next?

In earlier meetings, Leach had offered a presentation suggesting that the Board would use a combination of an electronic credentialing system and pool attendants to open the pool from May through September, from 6:00 am to 9:00 pm.

The details of that — including the cost and administration of the credentialing system — have yet to be worked out, and Board approval will be required for purchase of that system.

Leach said that he and the SLLA's new Community Manager would work out the details, assuming that his motion to utilize only attendants is approved at the March 3 Open Meeting.

Extending perimeter fence

Also during their Thursday, February 25 Work Session, the Board agreed to extended the community's perimeter fence along the north side of Seven Lakes Drive at its eastern end, near the intersection with Carthage Road.

Nine sections of fence will be added, in order to protect a new home on Cardinal Lane and prevent unauthorized entry into the community by ATVs and dirt bikes. Split rail fencing, removed when the pasture fence was replaced, will be utilized.

Moved to Open Meeting

Also during their Thursday, February 25 Work Session, the SLLA Board moved to the March 3 Open Meeting for a final decision:

• Approval of a \$7,349 contract with Atlantic Pyrotechnics for Fourth of July fireworks.

- Approval of a revision to Section 1.2.1.1 of the Rules and Regulations that redefines an Association "member." Couples legally married at the time the Seven Lakes property was acquired are both "members" regardless of whether both names appear on the deed. In the case of couples not married when the property was acquired, only the individual whose name appears on the deed is a member.
- Approval of a revision to Section 1.2.1.2 that defines

- "affiliate member" as spouses not named on the deed, as well as children of a member residing in the home.
- Establishing an Equestrian Club, through the Recreation Committee, with the mission to "propose, promote, and support the approved activities of the Seven Lakes Equestrian Center Stables."
- Approval of a fee schedule that eliminates the barcode discount for Seven Lakes Golf and Seven Lakes Health & (See "SLLA," p. 29)

If you don't have or can't find your ID, "come anyway," Clendenin said. "There are alternative methods for many people."

"No one should stay away from the polls because they don't have their ID card," she said.

Those who arrive at the polls without valid ID will be allowed to vote, and their

vote will be counted if they ers help you sort it out. present a valid ID at the Board of Elections Office before the official canvass takes, place.

Folks over 70 whose driver's license or other ID has expired may be able to use the expired ID.

And folks who have just moved to Moore County may be able to use their out-ofstate license or ID.

In short, if you have doubts. go vote, and let the poll work-

Vote for US Representative

The courts have thrown North Carolina's Congressional districts into a bit of disarray, after finding that the General Assembly improperly used race as the primary factor in drawing the first and twelfth Congressional districts.

The General Assembly has redrawn the map entirely and delayed the Congres-

sional primary election until June 7. If those new maps hold, Moore County will move from the Second Congressional District back into the Eighth.

Clendenin advises voters to ignore the hubbub and "vote your complete ballot." The State Board of Elections will figure out what to do about those votes for US Representative once the dust has settled.

Unaffiliated? Take your pick

In North Carolina, voters registered unaffiliated can chose to vote in the Republican, Democratic, or Libertarian Primaries — but only in one. Or, if they prefer to vote in none of those, they can accept an unaffiliated ballot, which will still allow them to vote on ballot measures, like the quarter-cent sales tax increase for schools.

Candidate dropouts

The names of some candidates who have announced that they have dropped out of the Presidential race will nevertheless appear on the Primary ballot, Clendenin said.

Her advice is to pick the candidate your prefer, regardless of what you might have read in the news about the suspension of one campaign or another.

Fitness, standardizing the fee for most non-members to \$15 initially, with a \$5 renewal fee. The fee for a golf cart sticker will be raised from \$3 to \$10.

Other Business

In other business:

 The Board discussed but rejected a proposal to assign the SLLA President the task of counting proxy ballots following the close of voting. Director Racine explained

that the vote counting committee will count the number of proxies assigned to the Board, and the Board will meet prior to the Annual Meeting to determine how to vote those proxies.

• President Leach announced that the current SLLA document retention policy is being reviewed for conformance to the NC Planned Community Act and state statutes. Once that review is complete, the policy will be brought to a future

Work Session. The current policy ignited a controversy when it was used as a rational for not releasing the proposed FY2107 budget to the membership prior to the Board's vote to approve it.




